# Data protection developments in Germany

We continue our coverage of developments in Germany with this summary of the latest issue of *Recht der Datenverarbeitung (RDV)*. #### Data protection in a multimedia world

The expansion of the information society and evolving computer technology have created new responsibilities and tasks in the area of data protection. Dr Joachim Jacob, Germany's Federal Data Protection Commissioner, introduces the challenges posed by multimedia systems in his address to the 19th Data Protection Conference (Cologne, November 1995) and presents different approaches to resolving them.

### Europe and new information and telecommunications technologies

Jörg Wenzel, in his capacity as Commissioner Dr Martin Bangemann's Cabinet Chief at the European Commission in Brussels, addressed the GDD 19th Data Protection Conference (Cologne, November 1995) on new technologies. In this summary, he covers developments such as the Internet, teleworking and ISDN, and concludes that it is necessary to intensify discussion between industry, administration and data protection managers. #### The European Data Protection Directive - implementation in Member States
