### Your Excellency,

With reference to the correspondence between the Embassy and your Department regarding the abolition of the consular visa on bills of health, I have the honour to inform you that the Government of the Republic is prepared to conclude with the Royal Government the following Arrangement:

"Subject to reciprocity, each of the two Governments shall henceforward cease to require vessels entering the ports of its home territory and flying the flag of the other State to produce the visa of its consuls on bills of health, irrespective of the ports at which the aforesaid vessels have previously put in.

"The present Arrangement shall not apply to vessels entering the non-Mediterranean ports of the colonies, protectorates, mandated territories and possessions of the two States, where the present regulations regarding the production of bills of health and visas shall remain in full force."

I should be grateful if you would be good enough to confirm your concurrence in the foregoing declarations.

YOUR EXCELLENCY,

With reference to your letter of July 19th, No. 552, regarding the abolition of the consular visa on bills of health, I have the honour to inform you that the Royal Government is in agreement with the Government of the Republic concerning the adoption of the provisions hereinafter reproduced:
