RESOLUTION ADOPTED BY THE GENERAL ASSEMBLY

[on the report of the Second Committee (A/48/721)]

48/185. Implementation of the commitments and policies agreed upon in the Declaration on International Economic Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries, and implementation of the International Development Strategy for the Fourth United Nations Development Decade

The General Assembly,

<u>Reaffirming</u> the Declaration on International Economic Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries, contained in the annex to its resolution S-18/3 of 1 May 1990, and the International Development Strategy for the Fourth United Nations Development Decade, contained in the annex to its resolution 45/199 of 21 December 1990, which provide the overall framework for economic growth and development,

<u>Recalling</u> its resolutions 46/144 of 17 December 1991 and 47/152 of 18 December 1992 on the implementation of the Declaration and the International Development Strategy,

1. Takes note of the report submitted by the Secretary-General, $\underline{1}$ / as requested in its resolution 46/145 of 17 December 1991, on regional economic integration among developing countries;

2. <u>Stresses</u> the need for the full and timely implementation of the commitments and policies agreed upon in the Declaration on International Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries, and in the International Development Strategy for the Fourth United Nations Development Decade;

3. <u>Encourages</u> Member States that have not yet submitted their reports on the implementation of the commitments and policies agreed upon in the Declaration and in the International Development Strategy to do so;

4. <u>Decides</u>, in order to monitor the progress made in the implementation of the Declaration and the International Development Strategy, and to facilitate the deliberations on the analytical and comprehensive report of the Secretary-General on the subject, as requested in its resolution 47/152, to include in the provisional agenda of its forty-ninth session the item entitled "International cooperation for economic growth and development: (<u>a</u>) Implementation of the commitments and policies agreed upon in the Declaration on International Economic Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries; (<u>b</u>) Implementation of the International Development Strategy for the Fourth United Nations Development Decade";

5. <u>Requests</u> the Secretary-General to include in his analytical and comprehensive report on the implementation of the commitments and policies agreed upon in the Declaration and in the International Development Strategy information on the difficulties encountered in implementing the commitments, and the measures that have to be taken by Member States for the expeditious and full implementation of the agreements contained therein.
