## RESOLUTION ADOPTED BY THE GENERAL ASSEMBLY

[without reference to a Main Committee (A/50/23, Part II)]

50/40. Dissemination of information on decolonization

The General Assembly,

<u>Having examined</u> the chapter of the report of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples relating to the dissemination of information on decolonization and publicity for the work of the United Nations in the field of decolonization,  $\underline{1}/$ 

<u>Recalling</u> its resolution 1514 (XV) of 14 December 1960, containing the Declaration on the Granting of Independence to Colonial Countries and Peoples, and other resolutions and decisions of the United Nations concerning the dissemination of information on decolonization, in particular General Assembly resolution 49/90 of 16 December 1994,

<u>Recognizing</u> the need for flexible, practical and innovative approaches towards reviewing the options of self-determination for the peoples of Non-Self-Governing Territories with a view to achieving complete decolonization by the year 2000,

<u>Reiterating</u> the importance of dissemination of information as an instrument for furthering the aims of the Declaration, and mindful of the role of world public opinion in effectively assisting the peoples of Non-Self-Governing Territories to achieve self-determination,

<u>Aware</u> of the role of non-governmental organizations in the dissemination of information on decolonization,

1. <u>Approves</u> the chapter of the report of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples relating to the dissemination of information on decolonization and publicity for the work of the United Nations in the field of decolonization;

2. <u>Considers it important</u> to continue its efforts to ensure the widest possible dissemination of information on decolonization, with particular emphasis on the options of self-determination available for the peoples of Non-Self-Governing Territories;

3. <u>Requests</u> the Department of Political Affairs and the Department of Public Information of the Secretariat to take into account the suggestions of the Special Committee to continue their efforts to take measures through all the media available, including publications, radio and television, as well as the Internet, to give publicity to the work of the United Nations in the field of decolonization and, <u>inter alia</u>:

 $(\underline{a})$  To continue to collect, prepare and disseminate basic material on the issue of self-determination of the peoples of Non-Self-Governing Territories;

 $(\underline{b})$  To seek the full cooperation of the administering Powers in the discharge of the tasks referred to above;

(<u>c</u>) To maintain a working relationship with the appropriate regional and intergovernmental organizations, particularly in the Pacific and Caribbean regions, by holding periodic consultations and exchanging information;

 $(\underline{d})$  To encourage involvement of non-governmental organizations in the dissemination of information on decolonization;

 $(\underline{e})$  To report to the Special Committee on measures taken in the implementation of the present resolution;

4. <u>Requests</u> all States, including the administering Powers, to continue to extend their cooperation in the dissemination of information referred to in paragraph 2 above;

5. <u>Requests</u> the Special Committee to follow the implementation of the present resolution and to report thereon to the General Assembly at its fifty-first session.
