## Resolution adopted by the General Assembly

[on the report of the Fifth Committee (A/63/787)]

### 63/273. Financing of the United Nations Mission in the Sudan

*The General Assembly,*

*Having considered* the note by the Secretary-General on the financing arrangements for the United Nations Mission in the Sudan for the period from 1 July 2008 to 30 June 2009<sup>1</sup> and the related report of the Advisory Committee on Administrative and Budgetary Questions,<sup>2</sup>

*Recalling* Security Council resolution 1812 (2008) of 30 April 2008, in which the Council decided to extend the mandate of the Mission until 30 April 2009,

*Recalling also* its resolution 62/267 of 20 June 2008 on the financing of the Mission,

1. *Endorses* the conclusions and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions,<sup>2</sup> and requests the Secretary-General to ensure their full implementation;

#### **Budget estimates for the period from 1 July 2008 to 30 June 2009**

2. *Decides* to appropriate to the Special Account for the United Nations Mission in the Sudan the amount of 56,173,100 United States dollars for the maintenance of the Mission for the period from 1 July 2008 to 30 June 2009, in addition to the amount of 820,720,600 dollars already appropriated for the maintenance of the Mission for the period from 1 July 2008 to 30 June 2009 under the terms of its resolution 62/267;

#### **Financing of the appropriation**

3. *Also decides*, taking into account the amount of 715,642,666 dollars already apportioned under the terms of its resolution 62/267 for the period from 1 July 2008 to 30 April 2009, to apportion among Member States the additional amount of 42,129,825 dollars for the period from 1 July 2008 to 30 April 2009, in accordance with the levels updated in General Assembly resolution 61/243 of

22 December 2006, and taking into account the scale of assessments for 2008 and 2009, as set out in its resolution 61/237 of 22 December 2006;

4. *Further decides* that, in accordance with the provisions of its resolution 973 (X) of 15 December 1955, there shall be set off against the apportionment among Member States, as provided for in paragraph 3 above, their respective share in the Tax Equalization Fund of 973,833 dollars, representing the increase in the estimated staff assessment income approved for the Mission for the period from 1 July 2008 to 30 April 2009;

5. *Decides*, taking into account the amount of 143,128,534 dollars already apportioned under the terms of its resolution 62/267 for the period from 1 May to 30 June 2009, to apportion among Member States the additional amount of 8,425,965 dollars at a monthly rate of 4,212,982 dollars for the period from 1 May to 30 June 2009, in accordance with the levels updated in General Assembly resolution 61/243, and taking into account the scale of assessments for 2009, as set out in its resolution 61/237, subject to a decision of the Security Council to extend the mandate of the Mission;

6. *Also decides* that, in accordance with the provisions of its resolution 973 (X), there shall be set off against the apportionment among Member States, as provided for in paragraph 5 above, their respective share in the Tax Equalization Fund of 194,767 dollars, representing the increase in the estimated staff assessment income approved for the Mission for the period from 1 May to 30 June 2009;

7. *Further decides* to keep under review during its sixty-third session the item entitled "Financing of the United Nations Mission in the Sudan".
