Berlin, April 4, 1925.

No. 957. — ACCORD¹ COMMERCIAL PROVISoire ENTRE L'ALLEMAGNE ET L'UNION ÉCONOMIQUE BELGO-LUXEMBOURGEOISE, SIGNÉ A BERLIN, LE 4 AVRIL 1925.

German and French official texts communicated by the Belgian Minister for Foreign Affairs. The registration of this Agreement took place October 7, 1925.

SA MAJESTÉ LE ROI DES BELGES, agissant tant en Son Nom qu'au Nom de SON ALTESSE ROYALE LA GRANDE DUCHESSE DE LUXEMBOURG, en vertu d'accords existants, d'une part, et le Président du Reich Allemand d'autre part, également animés du désir de développer les relations commerciales entre l'Union Economique belgo-luxembourgeoise et l'Allemagne, ont résolu de conclure à cet effet un Accord commercial provisoire et ont nommé pour leurs Plénipotentiaires, savoir :

M. Fernand VAN LANGENHOVE, Directeur, Chef de la Section de Politique commerciale au Ministère des Affaires étrangères.

LE PRÉSIDENT DU REICH ALLEMAND :

Monsieur le docteur Karl RITTER, Directeur ministériel au Département des Affaires étrangères.

Lesquels, après s'être communiqué leurs pleins pouvoirs respectifs, trouvés en bonne et due forme, sont convenus des articles suivants :

Article 1.

Les ressortissants de chacune des Parties contractantes pourront, de la même manière que les ressortissants de la nation la plus favorisée, pénétrer sur les territoires de l'autre Partie contractante, y voyager, y séjourner ou s'y établir. Ils jouiront également sur les territoires de l'autre Partie, en ce qui concerne l'exercice du commerce et des industries, l'acquisition de biens meubles et immeubles, des mêmes droits que les ressortissants de la nation la plus favorisée à cet égard.

Article 2.

En matière de taxes (impôts et droits de douane), de redevances pour autant quelles soient analogues à des impôts et autres charges similaires, les ressortissants de chacune des Parties con-

No. 957. — PROVISIONAL COMMERCIAL AGREEMENT BETWEEN GERMANY AND THE ECONOMIC UNION OF BELGIUM AND LUXEMBURG, SIGNED AT BERLIN, APRIL 4, 1925.

HIS MAJESTY THE KING OF THE BELGIANS, acting both on his own behalf and, in virtue of existing agreements, on behalf of HER ROYAL HIGHNESS THE GRAND DUCHESS OF LUXEMBURG, of the one part, and THE PRESIDENT OF THE GERMAN REICH, of the other part, desirous of developing the commercial relations between the Belgo-Luxemburg Economic Union and Germany, have resolved to conclude a provisional commercial agreement with that object, and have appointed as their Plenipotentiaries :

HIS MAJESTY THE KING OF THE BELGIANS :

M. Robert EVERTS, His Envoy Extraordinary and Minister Plenipotentiary at Berlin ;
M. Fernand VAN LANGENHOVE, Director, Chief of the Section of Commercial Policy in the Ministry for Foreign Affairs ;

THE PRESIDENT OF THE GERMAN REICH :

Dr. Karl RITTER, Ministerial Director in the Department of Foreign Affairs ;

who, having communicated their full powers, found in good and due form, have agreed upon the following articles.

Article 1.

The nationals of each of the Contracting Parties may, in the same manner as the nationals of the most favoured nation, enter the territories of the other Contracting Party and travel, stay, or settle therein. They shall also enjoy in the territories of the other Party, as regards the carrying on of trade and industry and the acquisition of movable and immovable property, the same rights in this respect as the nationals of the most favoured nation.

Article 2.

In the matter of imposts (taxes and Customs duties), dues, so far as they are analogous to taxes, and other similar charges, the nationals of each of the Contracting Parties shall enjoy in every respect in the territories of the other Party, both for their person and for their property, rights and interests, the same treatment and the same protection from the fiscal authorities and jurisdictions as the nationals of the most favoured nation.

Article 3.

Internal duties which are levied in the territory of one of the Contracting Parties on the production, manufacture or consumption of a commodity shall on no account, whatever may be the

body for whose benefit the duties are levied, be imposed upon the products of the other Party to a greater degree or in a more irksome manner than upon the similar products of the country itself.

Article 4.

The products of the soil and industry of the Belgo-Luxemburg Economic Union imported into Germany, and the products of the soil and industry of Germany imported into the territory of the Belgo-Luxemburg Economic Union shall not be subjected to other or higher duties than those imposed upon the similar products of the soil and industry of any third country.

The preceding clause shall not, however, apply to the products of the soil and industry of Germany enumerated in Annex I during the period specified in column 3 of that Annex, nor to the products of the soil and industry of the Belgo-Luxemburg Economic Union enumerated in Annex II during the period specified in column 3 of that Annex.

The import duties specified in column 4 of Annexes I and II shall be reciprocally applicable as regards the goods and the periods indicated in those annexes.

Article 5.

Without prejudice to the provisions of Article 4, paragraph 3, the products of the soil and industry of Germany enumerated in Annex III, when imported into the territories of the Belgo-Luxemburg Economic Union and the products of the soil and industry of the Belgo-Luxemburg Economic Union enumerated in Annex IV, when imported into Germany, shall not be subjected to higher import duties than those specified in column 3 of those annexes.

Article 6.

The goods traffic between the Parties shall not be impeded by any import or export prohibition or restriction.

Nevertheless, the Contracting Parties reserve the right to prohibit or restrict importation and exportation in the following cases, provided that such prohibitions or restrictions are at the same time applicable to all other countries in the same situation :

- (a) for reasons of public safety ;
- (b) in order to safeguard public health or to protect useful animals and plants against diseases or parasites ;
- (c) for war supplies in exceptional circumstances ;
- (d) in order to make it possible to extend to foreign goods prohibitions or restrictions which are or may in future be established by internal legislation in respect of the production, exchange, consumption or transport within the country of the same goods produced in that country. This provision has special reference to goods which constitute a State monopoly or a monopoly of a similar nature.

Further, the Contracting Parties reserve the right to prohibit or restrict the exportation of essential foodstuffs and raw materials — provided that such prohibitions or restrictions are at the same time and in the same manner applicable to all other countries — in the event of their national food supplies or the supplies necessary for their industries being seriously threatened as regards the said products or materials owing to exceptional circumstances. Should either of the Contracting Parties take advantage of this right, consideration shall be given, at the request of the other Party, to the possibility of granting exceptions or allowing quotas in order to injure as little as possible the commercial relations between the countries concerned ; and the other Party shall have the right to prohibit or restrict the exportation of the same articles for the same period without being required, in this exceptional case, to apply this measure to other countries.

Article 7.

There shall be freedom of transit from and to each of the Contracting Parties through the territory of the other Party.

Nevertheless, the Contracting Parties reserve the right to prohibit or restrict transit in the following cases, provided that such prohibitions or restrictions are at the same time applicable to all other countries in a similar situation :

- (a) for reasons of public safety ;
- (b) to safeguard public health or to protect useful animals and plants against diseases or parasites ;
- (c) for war supplies in exceptional circumstances.

No transit dues shall be levied.

The provisions of the present article shall also apply to goods in transit which have been transhipped, repacked or warehoused, provided always that the necessary precautions to prevent the goods remaining in the country are taken in accordance with the regulations in force.

Article 8.

Merchants, manufacturers, and other industrialists who prove by the production of trading certificates issued by the authorities of their own country that they are authorised to carry on a trade or industry in the territories of that Contracting Party in which they are domiciled, and that they pay dues and taxes in that territory according to law, may, either in person or through commercial travellers in their employ, purchase goods in the territory of the other Contracting Party from merchants at open or public places of sale or from producers, and take orders from merchants at their business premises or from persons using in their business goods of the same kind as those offered. They shall not be subjected to any special taxes or dues on this account ; they may take with them samples and patterns.

The two Contracting Parties agree to apply in this connection the provisions of the International Convention for the Simplification of Customs Formalities concluded at Geneva on November 3rd, 1923, but at the same time they undertake to secure to each other the rights of the most favoured nation.

Article 9.

Limited and other commercial companies, including industrial, financial and insurance companies and companies concerned with communications and transport, which are incorporated in the territory of one of the Contracting Parties and have their headquarters therein, shall be recognised as legal entities in the territory of the other Party. Their constitution, legal capacity, and right of access to the courts shall be judged in accordance with the laws of the country in which their headquarters are situated.

The granting of authorisation to engage in commercial activities in the territory of the other Party and to acquire movable and immovable property therein shall be governed by the laws and regulations in force in that territory. Nevertheless, companies which have obtained the requisite authorisation shall enjoy in those territories rights, privileges and immunities at least as great as those enjoyed by legally recognised companies of the same kind belonging to the most favoured nation.

Article 10.

No discrimination shall be made on the railways between the inhabitants of the territories of the Contracting Parties, either as regards rates or as regards the time and method of despatch. In particular, consignments proceeding from the territory of one of the Contracting Parties to the

territory of the other, or in transit therethrough, shall receive, as regards despatch and rates, treatment at least as favourable as consignments proceeding from their respective territories to destinations within the country or abroad, provided that they are carried over the same lines and in the same direction.

Article 11.

German vessels and their cargoes in Belgium, and Belgian vessels and their cargoes in Germany, shall receive the same treatment in every respect as national vessels and their cargoes, irrespective of the port of departure or destination of the vessels and the origin or destination of the cargoes.

This provision shall not apply to the coasting trade and coastal fisheries in territorial waters, which shall continue to be governed by the legislation of each of the two countries. Nevertheless, German and Belgian vessels shall be free to sail from a port in the territory of one of the Contracting Parties to a port or ports in the same country in order to discharge the whole or part of a cargo brought from another country, or to take up or complete a cargo for another country. If, however, one of the Contracting Parties should grant more extensive rights to a third country, those rights shall also, subject to reciprocity, be granted to the other Contracting Party.

The nationality of vessels shall be recognised by both Parties, in accordance with the laws and regulations of each country, as being established by the documents and ship's papers issued by the competent authorities.

A special agreement shall, as soon as possible, be concluded between the two Contracting Parties for the reciprocal recognition of tonnage certificates.

Pending the conclusion of the above-mentioned agreement, tonnage certificates shall be reciprocally recognised in accordance with the agreements already concluded.

German vessels proceeding to a Belgian port, and Belgian vessels proceeding to a German port, for the sole purpose of completing their cargo or discharging a part thereof, shall have the right, provided that they conform to the laws and regulations of the country, to retain on board and re-export such part of the cargo as may be consigned to another port in the same country or in a third country, and shall not be required to pay in respect of that portion of their cargo any charges except supervision dues. These dues shall not be higher than those imposed on vessels of any third country.

Article 12.

The vessels, shipping companies and emigration undertakings of each of the Contracting Parties shall enjoy in the territory of the other Party the same treatment as those of that Party in all matters affecting the engagement and conveyance of emigrants coming from their respective territories, or having passed in transit therethrough, and embarking either at a Belgian or at a German port; the same shall apply to the establishment of agencies by such companies or undertakings.

Article 13.

As regards navigation and all dues and charges connected therewith, each of the Contracting Parties shall grant, on its natural or artificial inland waterways and in its inland ports open to traffic, at least as favourable treatment to the vessels of the other Party engaged in inland navigation and their cargoes and crews as to those of its own nationals or of the most favoured nation.

Article 14.

Each of the Contracting Parties shall, subject to the customary rules and usages, admit the Consuls of the other Party to all places of trade to which the Consuls of any third country are

admitted. The word "Consul" shall be understood to mean any person invested with consular authority.

Subject to reciprocity, the Consuls of each of the Contracting Parties shall enjoy in the territory of the other Party the same rights, privileges and immunities as the Consuls of any third country.

Article 15.

The provisions of Articles 2, 3, 4 (paragraph 1), 6, 7, 8, 9 (paragraph 1), 10, 11, 13 and 14 of the present Agreement shall be applicable to the Belgian Colony of the Congo and to the territories administered by Belgium in Africa. The goods of the Belgian Colony of the Congo and of the territories administered by Belgium in Africa shall not be liable, on their importation into Germany, to higher import duties than those fixed in Annex IV.

Article 16.

The Contracting Parties will determine by special agreement the traffic facilities to be accorded to the inhabitants of the frontier zones, in particular as regards :

- (1) The importation of certain products destined for consumption and use by the said inhabitants ;
- (2) The exploitation of the estates divided by the frontier ;
- (3) The carrying on of agricultural and forestry work on estates situated on the other side of the frontier ;
- (4) The sending of cattle to pasture-land or to a slaughter-house on the other side of the frontier ;
- (5) The local finishing and repairing traffic ;
- (6) The movement of vehicles and the conditions under which the said inhabitants may make a stay in the opposite frontier zone.

Article 17.

The present Agreements shall be ratified and the ratifications shall be exchanged at Berlin as soon as possible.

It shall come into force on the fifteenth day after the exchange of ratifications. It may be denounced by either of the Contracting Parties, subject to six months' notice ; it may not, however, be denounced until the expiration of a period of 18 months from the date of its coming into force.

In faith whereof the Plenipotentiaries have signed the present Agreement and have affixed their seals thereto.

Done in duplicate at Berlin in French and German on April 4, 1925.

FINAL PROTOCOL.

Ad Article 1.

The provisions of Article 1 shall not in any way affect the application of the regulations in force in Belgium, in the Grand Duchy of Luxemburg and in Germany with regard to the passport

régime (journey visa, residence visa, charges in connection with the grant of these visas, etc.). The two Contracting Parties recognise that the exception thus made may not be invoked in order to exclude from the benefit of the provisions of Article 1 entire categories of persons.

Ad Articles 2 and 9.

In consideration of the provisional character of the present Agreement, the German Government withdraws its request for the application of national treatment in respect of the fiscal system applicable to physical and legal persons, and declares itself satisfied with most-favoured-nation treatment. Nevertheless, the two Contracting Parties agree to take national treatment as the basis for the discussion of this question when negotiations are entered into for a permanent commercial treaty.

Ad Articles 4 and 5.

The import duties fixed in Annexes I and III in respect of the goods enumerated therein may be increased, but this shall only be done if the average index of wholesale prices in Belgium has risen by at least 20 per cent, as compared with such index at the moment when the Agreement is signed. They may only be increased in proportion to the rise of such index. The duties must be reduced to their original level as soon as the index reaches the point at which it stood at the moment when the Agreement was signed.

The Belgo-Luxembourg Economic Union further reserves the right to convert into equivalent specific duties the *ad valorem* duties specified in the present Agreement.

Ad Article 5.

(1) Each Contracting Party agrees, in the event of its modifying its present Customs system, to have due regard, in so far as such modifications may specially affect the interests of the other Party, to reciprocity and to the development of the trade of the two countries on equitable lines.

If one of the two Contracting Parties should consider that any Customs duties established by the other Party are at variance with the preceding engagement, the two Parties declare themselves willing to enter into oral negotiations immediately on the subject.

(2) In the event of Germany imposing lower rates of duty in respect of other breeds of horses, such reduced rates shall also apply, as long as they are in force and on the same conditions, to horses of Belgian origin, belonging to the Flemish, Brabant and Ardennes breeds.

(3) The *ad valorem* duty fixed in Annex IV in respect of imitation crystal-ware or similar glassware shall be calculated on the value at the place of origin or manufacture of the imported article, plus the necessary expenses in connection with transport, insurance and commission as far as the place at which it is cleared through the Customs.

(4) As regards the interpretation of the articles hereinafter enumerated of the Belgian Customs tariff, it is agreed as follows:

No. 382. In the case of prepared medicaments, compounded preparations and patent medicines, which are imported in cachets, phials, or tablets not packed in the wrapping which passes into the hands of the retail purchaser, the duties shall be calculated on the same basis as in the case of all other goods subject to *ad valorem* duties and imported in the same manner.

No. 771. The following articles are to be included under this heading: alphabets, botanical and zoological atlases, illustrated collections of tales and stories, picture books, including puzzle picture books, etc., for the use of children, when such articles are made either of sheets of cardboard weighing 300 grammes or more per square metre or of paper gummed on cloth.

No. 775. The following articles shall be regarded as coming under this heading : books and pamphlets containing black and white or coloured reproductions of works of art (paintings, drawings, sculptures, etc.), and all *objets d'art* or non-commercial articles for collections. Bibliographical magazines and catalogues of scientific material and objects destined for use in teaching shall be admitted on the same footing as books.

No. 781. In the case of block calendars where the block is provided with a cover or title leaf in several colours, the manner in which this is printed need not be taken into account. Similarly, a calendar, each of whose leaves is printed entirely in one colour, but the leaves of which differ from each other in shade, shall be regarded as being printed in a single colour.

Nos. 779, 781, 782, 783 and 784. The provisions of Note I concerning Nos. 779, 781, 782, 783 and 784 of the Belgian tariff shall be interpreted as meaning that varnishing, gelatinating, gumming, and embossing shall be taken into consideration in determining the number of colours, but pressing and other similar operations shall be disregarded.

No. 1214. The following articles shall be regarded as *objets d'art* and non-commercial articles for collections : Engravings, etchings and other similar artistic reproductions made by incision on metal plates, even if they are in several colours, provided that the works fulfil the following conditions :

- (1) They must be signed and numbered by the artist himself ;
- (2) They must be reproduced on hand-made paper (on uncut sheets) and must show a margin and the impress of the plate ;
- (3) The consignments must not contain more than ten examples of the same work.

The Belgian Government will lay before Parliament a draft law for deleting from General Note No. I applicable to Section XIX of the Customs Tariff mouth organs and accordions without half-tones.

Ad Article 6.

1. If the Contracting Parties should consider it necessary to maintain an import or export prohibition or restriction in respect of certain goods, they will communicate to each other the list of such goods before the ratification of the Agreement. They further agree to apply in this matter the provisions of the International Convention for the Simplification of Customs Formalities concluded at Geneva on November 3, 1923.

2. The provisions of Article 6 shall not in any way affect the provisions of international agreements concerning the importation and exportation of arms, munitions and implements of war.

3. The system of licences at present in force in respect of the importation of German coal into Belgium is not designed to diminish the proportion which such imported coal bears to the total amount of foreign coal imported into Belgium under free market conditions, but solely to ensure a market for the German coal supplied on reparation account. Consequently, as long as this system is maintained, the Belgian Government undertakes — subject to the adoption of exceptional measures in the event of the sale of the German coal supplied to Belgium on reparation account in accordance with the London Agreement of August 30, 1924, and with any subsequent agreements for the same purpose being adversely affected — to issue import licences in the same manner as heretofore to Belgian traders or consumers who can produce an authentic contract of sale concluded direct with a German producer.

If it should prove necessary to adopt the exceptional measures mentioned above, the Belgian Government will inform the German Government in advance and will examine with good-will any observations which the latter may submit.

The Belgian Government declares itself ready to examine the possibility, when circumstances permit, of substituting for the licence system another system guaranteeing an outlet for the German coal supplied to Belgium on reparation account.

4. The system of control to which aniline dyes are present subject on entering the Belgo-Luxembourg Economic Union shall only be maintained as regards Germany in so far as such control is necessary to ensure the supply of these dyes on reparation account, and in so far as it is applied at the same time to all other countries.

Ad Article 7.

The two Contracting Parties jointly agree that exemption from transit charges shall not in any way affect the transfer charges in respect of transactions concerning goods in transit during the period of warehousing or transportation.

Ad Article 10.

The Contracting Parties shall give each other every possible assistance as regards the fixing of the charges for transport by rail, in particular by establishing through rates whenever either of them makes a request to that effect in respect of goods which give rise to traffic in the direction mentioned.

They agree that the transport charges as well as any reductions in rates or other privileges which may be granted by means of local tariffs or by special regulations or by individual treaties to the products of their own country shall be made applicable on the same terms to similar consignments passing from the territory of one of the Contracting Parties to the territory of the other, or in transit through it, provided always that the transportation is effected on the same lines and in the same direction.

Consequently the transport charges which, by virtue of local tariffs or the tariffs of the Railway Unions, would be applicable on the line in question to goods for reconsignment shall be inserted in the through tariffs if the other Contracting Party so requests.

The only case to which the foregoing provisions do not apply is that of consignments destined for charitable or public utility organisations.

Ad Article 11.

The coasting trade referred to in Article 11 shall apply to the right to load goods in a port of one of the Contracting Parties and to transport them to another port of the same Contracting Party, situated on the same sea, in order to be unloaded there.

Ad Article 15.

The provisions of Article 6 in so far as they apply to the Belgian Colony of the Congo and the territories administered by Belgium in Africa shall in no way affect the right of the Belgian Government to prohibit or restrict importation and exportation into and out of the Colony and territories in question, provided always that such prohibitions or restrictions are made to apply at the same time and in the same manner to all other countries.
