No. 3527. — EXCHANGE OF NOTES BETWEEN THE ITALIAN AND YUGOSLAV GOVERNMENTS CONSTITUTING AN AGREEMENT RELATING TO NEGOTIATIONS FOR THE REVISION OF THE TREATY OF COMMERCE AND NAVIGATION OF JULY 14TH, 1924, AND OF THE ADDITIONAL AGREEMENT OF APRIL 25TH, 1932, AS WELL AS TO THE REVISION OF THEIR CONDITIONS OF DENUNCIATION. ROME, MAY 12TH AND JUNE 16TH, 1933.

Monsieur le Ministre.

Rome, May 12th, 1933.

As your Excellency is aware, there was concluded at Rome on April 25th, 1932, between the Royal Italian Government and the Royal Government of Yugoslavia, an Agreement additional to the Italo-Yugoslav Treaty of Commerce and Navigation of July 14th, 1924, which mainly

referred to changes in certain conventional duties provided for in the Treaty. This Agreement, however, which may be denounced as from June 1st next, together with the Treaty of Commerce, has not in practice, from the point of view of the interests of the national economy, produced the results Italy had hoped it would yield at the time of its conclusion. Consequently, the Royal Government desires that steps should be taken to revise it. In order, however, that the negotiations for the conclusion of a new Agreement may take place unhampered by any preoccupations with regard to time limits, it would be prepared to conclude immediately a Convention in the following terms:

"The Royal Government of Italy and the Royal Government of Yugoslavia shall appoint as soon as possible their respective delegates to open commercial negotiations for the revision of the tariff section of the Commercial Agreements at present in force between them. As, however, under Article 4 of the Additional Agreement of April 25th, 1932, to the Treaty of Commerce and Navigation of July 14th, 1924, these two acts may be denounced on June 1st, 1933, the denunciation to take effect six months later, i.e., on December 1st of this same year, the two Governments agree by these presents that they will not denounce it before October 1st next, but that if it be denounced on that date by one of the two High Contracting Parties this denunciation shall take effect two months later, i.e., on December 1st, 1933.

"It, however, the two above-mentioned acts are not denounced on October 1st, 1933, they shall remain in force indefinitely, though each of the High Contracting Parties may denounce them at any time so that they may cease to have effect two months after the

date of denunciation."

I have the honour to request your Excellency to be good enough to bring the foregoing to the knowledge of the Royal Government of Yugoslavia and to inform me whether it would be prepared to conclude a Convention on these lines. Moreover, as the Royal Government desires that in any case the Additional Agreement of April 25th, 1932, shall be replaced before December 1st next by the new Agreement to be concluded, I should be grateful if you would request your Government to take the necessary steps to make known its decisions as soon as possible and in any case before the end of this month.

I have the honour to acknowledge receipt of the following communication which Your Excellency was good enough to transmit to me in your letter No. 214566/13 of May 12th last to His Excellency the Yugoslav Minister in Rome:

them.
