No. 4446. — CONVENTION¹ BETWEEN GREAT BRITAIN AND NORTHERN IRELAND, THE COMMONWEALTH OF AUSTRALIA AND NEW ZEALAND AND THE GRAND DUCHY OF LUXEMBURG SUPPLEMENTARY TO THE TREATY² OF NOVEMBER 24TH, 1880, REGARDING EXTRADITION. SIGNED AT LUXEMBURG, JANUARY 23RD, 1937.

English and French official texts communicated by His Majesty's Secretary of State for Foreign Affairs in Great Britain. The registration of this Convention took place October 7th, 1938.

HIS MAJESTY THE KING OF GREAT BRITAIN, IRELAND AND THE BRITISH DOMINIONS BEYOND THE SEAS, EMPEROR OF INDIA, and HER ROYAL HIGHNESS THE GRAND DUCHESS OF LUXEMBURG,

Desiring to make further provision for the reciprocal extradition of fugitive criminals,

Have resolved to conclude a supplementary Convention for that purpose, and to that end have appointed as their Plenipotentiaries :

HER ROYAL HIGHNESS THE GRAND DUCHESS OF LUXEMBURG :

M. Joseph BECH, Grand-Cross of the Order of Adolph of Nassau, Grand-Officer of the Order of the Crown of Oak, etc., Her Minister of State, President of the Government ;

Who, having communicated their full powers, found in good and due form, have agreed as follows :

Article 1.

The High Contracting Parties agree that the provisions of the Extradition Treaty concluded at Luxemburg on the 24th November, 1880, shall apply to :

(1) The following British Protectorates, which are administered under the authority of His Majesty's Government in the United Kingdom, viz. : Bechuanaland Protectorate, Gambia Protectorate, Kenya Protectorate, Nigeria Protectorate, Northern Rhodesia, Northern Territories of the Gold Coast, Nyasaland, Sierra Leone Protectorate, Solomon Islands Protectorate, Somaliland Protectorate, Swaziland, Uganda Protectorate, Zanzibar, and

(2) The following British-protected States, which are administered on the advice of His Majesty's Government in the United Kingdom, viz. : Perak, Selangor, Negri Sembilan, Pahang, Johore, Kedah, Kelantan, Perlis, Trengganu and Brunei, and

(3) The following territories in respect of which mandates on behalf of the League of Nations have been accepted by His Majesty, viz. : Cameroons under British mandate, Togoland under British mandate, the Tanganyika Territory and Palestine (including Transjordan) (being territories in respect of which the mandates are exercised by His Majesty's Government in the United Kingdom of Great Britain and Northern Ireland), New Guinea (in respect of which the mandate is exercised by His Majesty's Government in the Commonwealth of Australia), Western Samoa (in respect of which the mandate is exercised by His Majesty's Government in the Dominion of New Zealand), and Nauru.

If after the signature of this Convention it should be considered advisable to extend its provisions to any British Protectorates or to any British-protected States, other than those mentioned, the High Contracting Parties agree that the Convention may be so extended by means of an agreement contained in an exchange of notes between the respective Governments, and that such extension shall take effect from the date prescribed in the notes to be exchanged for the purpose of effecting such extension.

Article 2.

Requisitions for extradition under the present Convention shall be made in accordance with the provisions of the Treaty of the 24th November, 1880, and as if the said Protectorates, protected States and mandated territories were possessions of His Majesty.

Article 3.

The present Convention shall be ratified and the ratifications shall be exchanged at Brussels as soon as possible. It shall come into force one month after the exchange of ratifications in conformity with the laws of the High Contracting Parties, and shall remain in force so long as the Extradition Treaty of the 24th November, 1880, and shall lapse with the termination of that Treaty.

In witness whereof, the respective Plenipotentiaries have signed the present Convention and have affixed thereto their seals.

Done in duplicate in English and French at Luxemburg, the twenty-third of January, in the year of our Lord one thousand nine hundred and thirty-seven.
