Sir,

I have the honour to refer to previous correspondence on the question of moneys held in New Zealand by the Custodian of Enemy Property under the provisions of the Enemy Property Emergency Regulations which are owing to Czechoslovak persons, and also in connection with amounts claimed by New Zealand persons from Czechoslovakians. Lists of such moneys and particulars of such claims as at 31 March 1946 have already been supplied to you.

I now have the honour to inform you that the New Zealand Government would be prepared to accept the following arrangements for the release of the monetary assets in question:—

(1) The New Zealand Government undertakes that all monetary assets in New Zealand belonging to Czechoslovak persons will be at their free disposal, subject to the exchange regulations for the time being in force in New Zealand, for transfer via London within the terms of the United Kingdom-Czechoslovakia Monetary Agreement signed in London on 1 November 1945<sup>2</sup>, on the understanding that the Government of the Czechoslovak Republic undertakes the same obligation,

subject to any exchange regulations for the time being in force in Czechoslovakia, with regard to monetary assets in Czechoslovakia belonging to New Zealand persons and concerns.

(2) The Government of Czechoslovakia recognises that Czechoslovak persons who are debtors to New Zealand persons remain liable to their creditors until the debts are fully discharged in accordance with the terms of the appropriate contracts. In this connection the Government of Czechoslovakia will assist New Zealand creditors to trace and identify their debtors and facilitate the enforcement of the claims of the creditors against the original debtors, their heirs or successors.

If the arrangements as proposed above meet with the approval of your Government, it is suggested that this letter, together with your reply informing me to this effect, shall constitute a formal agreement between our two Governments, taking effect from the date of your reply.

The Government of the Czechoslovak Republic has the honor of acknowledging the receipt of the communication of the New Zealand Government dated November 7, 1946 proposing to accept the following arrangements for the release of moneys held in New Zealand by the Custodian of Enemy Property under the provisions of the Enemy Property Emergency Regulations which are owing to Czechoslovak persons and also in connection with amounts claimed by New Zealand persons from Czechoslovakians. It is agreed that the following Agreement between the two Governments for the release of the monetary assets in question will be concluded:

Dr. Eduard Benes, President of the Czechoslovak Republic appointed and constituted me as his Plenipotentiary and vested me with Full Power to conclude and sign the afore-said agreement. In testimony whereof I am enclosing the copy of the full power signed by the President and countersigned by Mr. Jan Masaryk, Minister of Foreign Affairs.
