No. 452. PROTOCOL¹ OF THE MIXED AUSTRIAN-NOR-WEGIAN COMMISSION. SIGNED AT OSLO, ON 28 JAN-UARY 1949

Following the consultations which took place at Oslo from 20 to 28 January 1948 in the Joint Norwegian-Austrian Commission set up under article IV of the agreement concerning the exchange of goods between the two countries, signed on 27 November 1948, the Norwegian and Austrian delegates have agreed on the following:

1. In order to make it possible for Austria to utilize the drawing rights of U.S. \$1,500,000 granted to Austria by Norway in virtue of the Agreement for Intra-European Payments and Compensations, the Norges Bank shall open a credit enabling the Österreichische Nationalbank to draw beyond the sums available in its account with the Norges Bank (see article I of the agreement concerning the settlement of payments between the Kingdom of Norway and the Republic of Austria, signed on 27 November 1948) up to a sum corresponding to the total drawing rights still available.

Utilization of the drawing rights shall furthermore be effected in accordance with the regulations of the aforementioned Agreement for Intra-European Payments and Compensations.

2. Schedule A of Norwegian exports to Austria annexed to the agreement concerning the exchange of goods between the Kingdom of Norway and the Republic of Austria shall be supplemented by the addition of the following goods:

The provisions of this protocol shall come into force after they have been approved by the two Governments.
