Your Excellency,

In Article 9 of the Anglo-Danish Monetary Agreement of the 16th August, 1945, it was provided that the Agreement should not apply to the Faroe Islands until a date to be agreed between the two Contracting Governments.

- 2. I now have the honour to state that in discussions between representatives of Denmark and the United Kingdom it has been proposed that the provisions of the Anglo-Danish Monetary Agreement of the 16th August, 1945, should apply to the Faroe Islands, as provided for in Article 9 thereof, with effect from the 10th November, 1948.
- 3. His Majesty's Government in the United Kingdom of Great Britain and Northern Ireland have approved this proposal. I shall be grateful if your Excellency will inform me whether the Royal Danish Government likewise approve this proposal. I suggest that the Note from Your Excellency informing me of the approval of the Royal Danish Government should, together with the present Note, be regarded as constituting an Agreement between the two Governments to this effect.

I hereby beg to inform you that the Agreement concluded to-day between the Royal Danish Government and His Britannic Majesty's Government through exchange of Notes and according to which the provisions of the Anglo-Danish Monetary Agreement of August 16th, 1945, shall apply to the Faroe Islands, as provided for in article 9 thereof with effect from November 10th, 1948, will not affect the arrangement hitherto existing according to which the Sterling earnings of the Faroe Islands are at their disposal for the purchase of goods etc., in the United Kingdom.

Further I have to inform you that arrangement has been made between the Danish and the Faroese authorities for the necessary Sterling to meet outstanding payments due from the Faroe Islands to the United Kingdom to be made available by the Danmarks Nationalbank.
