#### MEMORANDUM

# ON THE LIQUIDATION OF CLEARING OPERATIONS STILL PENDING BETWEEN BELGIUM AND THE NETHERLANDS

1. All payment orders, including those relating to documentary credits, which have been credited to the Banque d'Emission or the Nederlandsche Clearinginstituut with the Deutsche Verrechnungskasse shall be executed, except those in respect of which the customary evidence of title has not been presented.

In determining whether the amount of a payment order has been credited with the Deutsche Verrechnungskasse, reference may be made to the confirmation by the Deutsche Verrechnungskasse that the amount has been duly debited.

2. An amount paid in for transfer to the Banque d'Emission or the Nederlandsche Clearinginstituut shall be repaid to the payer if no corresponding payment order has been recorded by the Deutsche Verrechnungskasse. 3. Payment orders within the categories referred to in paragraphe 1 above which have become inoperative, or in respect of which the customary evidence of title cannot be presented, shall be cancelled, and the institution which has actually received the funds shall repay the amount of such orders to the payer and shall be liable therefor.

4. When a payment order recorded by the Deutsche Verrechnungskasse has not been duly executed and the payer has subsequently made a second payment under the Belgian-Netherlands Monetary Convention of 21 October 1943,<sup>1</sup> the first order shall, if evidence of title was presented at the time of issue, be liquidated and the second payment retransferred under the said Monetary Convention.

5. The Banque d'Emission and the Nederlandsche Clearinginstituut shall agree upon the necessary technical arrangements for carrying out the liquidation in accordance with the provisions of this agreement. For this purpose they shall exchange detailed lists of all payment orders and credit advices pending on either side.

6. The present recommendations will be put into effect upon their approval by the Belgian and Netherlands Governments.

If, however, one of the Governments is not empowered without prior legislative authorization to give effect to any of these recommendations, that Government may defer the application thereof until it has obtained the necessary powers.
