## TRANSLATION — TRADUCTION

No. 755. EXCHANGE OF NOTES BETWEEN THE GOVERNMENTS OF BELGIUM AND MONACO CONSTITUTING AN AGREEMENT<sup>1</sup> FOR THE MUTUAL ABOLITION OF PASSPORTS. BRUSSELS, 31 JANUARY AND 6 FEBRUARY 1950

The Ministry of Foreign Affairs and External Trade has the honour in further reference to its note of 26 January to propose to the Legation of Monaco at Brussels the text of an agreement for the abolition of passports between the two countries.

1. Belgian nationals, whatever their country of residence, may enter and leave the Principality of Monaco, provided that they are in possession of one of the following documents :
  - (a) a national passport, even if it has expired, provided that it was issued or renewed after 1 October 1944;
  - (b) a Belgian identity card issued or renewed after 6 October 1944;
  - (c) an alien's identity card, which is still valid and was issued or renewed by a prefecture of Metropolitan France or of Algeria after 1 October 1944;
  - (d) an alien's identity card which is still valid and was issued or renewed by the Luxembourg authorities after 1 October 1944;
  - (e) an alien's identity card, which is still valid and was issued or renewed by the Monégasque authorities after 1 October 1944.
2. Belgian children under the age of 15 years who do not yet hold identity cards shall be authorized to enter the Principality of Monaco :
  - (a) if they are domiciled in Belgium, provided that they are in possession of an "identity certificate" to which a photograph has been affixed and which shows the civil status of the person concerned and was issued by the administration of the commune where they are domiciled after 1 October 1944;
