#### His Majesty's Ambassador at Athens to the Greek Minister for Foreign Affairs

#### **BRITISH EMBASSY**

Athens, 21st February, 1951

Your Excellency,

I have the honour to inform you that since both the United Kingdom of Great Britain and Northern Ireland and Greece are Contracting Parties to the General Agreement<sup>3</sup> on Tariffs and Trade, and since His Majesty's Government in the United Kingdom and the Government of Greece have negotiated a Tariff Agreement in accordance with the Annecy Protocol<sup>4</sup> of Terms of Accession to the General Agreement on Tariffs and Trade, His Majesty's Government in the United Kingdom propose that the first four paragraphs of Article 8 of the Treaty of Commerce and Navigation between the United Kingdom of Great Britain and Northern Ireland and Greece signed in London on 16th July, 1926,<sup>2</sup> and the Schedule to that Treaty,<sup>2</sup> shall be inoperative for such time as the United Kingdom of Great Britain and Northern Ireland and Greece are both Contracting Parties to the General Agreement on Tariffs and Trade as defined in Article XXXII thereof.

If the Royal Hellenic Government agree to this proposal I have the honour to suggest that the present Note and your reply to this effect shall be regarded as constituting an agreement on this matter between our two Governments.
