Sir,

I have the honour hereby to confirm the arrangement that His Majesty's Government in the United Kingdom should transfer to His Majesty's Government in the Union of South Africa the rights, title and interests which they formerly possessed in Marion Island and Prince Edward Island. His Majesty's Government in the United Kingdom have taken note that the national flag of the Union of South Africa was hoisted on Marion Island on 24th Dece mber 1947, and on Prince Edward Island on 4th January, 1948, and that effective government and administration of the Islands were established by His Majesty's Government in the Union of South Africa as from those dates; and consequently regard the transfer as complete as from those dates.
