No. 1359. AGREEMENT¹ BETWEEN THE UNITED NATIONS AND THE GOVERNMENT OF INDIA FOR THE PROVISION OF TECHNICAL ASSISTANCE TO THE GOVERNMENT OF INDIA. SIGNED AT NEW YORK, ON 14 AUGUST 1951

The United Nations (hereinafter referred to as "the Organization") and the Government of India (hereinafter referred to as "the Government"),
Considering the provisions of General Assembly resolution No. 200 (III),²

Have agreed as follows :

Article I

1. In accordance with the request of the Government, the Organization will provide the services of a Director and three expert lecturers for a period of three months, and the services of an executive secretary for a period of four months, for the purpose of organizing training in India in the techniques of Statistical Quality Control. The training will be conducted at such locations in India, and for such duration during a total period of three months beginning in 1951, as may be mutually agreed upon. The Government will arrange for the attendance of 25-30 suitable students at each such training centre organized during the period. The experts will also be available for consultation concerning training in, and development of Statistical Quality Control in India.

Article II

1. The Organization will, in respect of the technical assistance being provided as above, defray those costs which are payable outside the country, as follows :

- (a) The salaries of the Director, the three Lecturers, and the Executive Secretary, provided as in Article I (hereinafter referred to as "the U. N. personnel");

- (b) Subsistence and travel of the U. N. personnel from their place of recruitment to the place of entry into the country, as well as displacement allowance where applicable;
- (c) Any other necessary travel expenses of the U. N. personnel outside the country;
- (d) Insurance of the U. N. personnel;
- (e) Any other expenses incurred outside the country and necessary for the provision of this technical assistance.

2. The Government will assume responsibility for such part of the costs of the technical assistance to be provided as can be paid in local currency as follows :

- (a) Subsistence expenses of the U. N. personnel being provided at the rate of 55 rupees per diem approved by the Technical Assistance Board, or actual expenses of board and lodging of equivalent standard, which may be provided for;
- (b) Medical care and hospitalization for the U. N. personnel;
- (c) Transportation of the U. N. personnel and of equipment and supplies within the country in connection with the furnishing of technical assistance and all official telephone, telegraph, postal and other communication expenses;
- (d) Any taxes or other duties or levies collected by the Government not covered by the privileges and immunities under Article III.

3. In addition to other payments under this Article, the Government shall provide to the U. N. personnel, at its own expense, after consultation with the Director :

- (a) Adequate office facilities, office supplies and equipment, as well as suitable facilities for the holding of lectures, discussions, etc.;
- (b) The necessary local secretarial and related assistance;
- (c) Any other facilities mutually agreed upon.

The Government will assume all administrative and financial responsibilities related to the provision of the facilities specified in this paragraph.

4. For the purpose of meeting its obligations under paragraph 2 above, the Government shall establish, maintain and place at the disposal of the Organization a local currency fund in the amount of Rs. 50,000, of which Rs. 35,000 would be available to cover expenses incurred under sub-paragraph (a) of paragraph 2 of this Article, and the remaining Rs. 15,000 to cover miscellaneous expenses under sub-paragraphs (b), (c) and (d) of paragraph 2 of this Article. Any unused balance shall be returned to the Government, after due rendering of accounts.

5. In lieu of making payment in accordance with paragraph 2 above, the Government may give supplies and services in kind, to the extent that may be mutually agreed upon.

Article III

The Government shall, in conformity with the Convention on the privileges and Immunities of the United Nations¹ (to which it has acceded), issue any necessary administrative instructions according to the Organization, its personnel, property and assets in the country, all the privileges and immunities which are normally accorded under the provision of that convention.

Article IV

1. This Agreement shall come into force upon signature.
2. This Agreement may be modified by agreement between the Organization and the Government, each of which shall give full and sympathetic consideration to any request by the other for such modification.
3. This Agreement may be terminated by either party upon written notice to the other, and shall terminate sixty days after receipt of such notice.

IN WITNESS WHEREOF the undersigned, duly appointed representatives of the Organization and the Government respectively have, on behalf of the Parties, signed this Agreement at New York this 14th day of August, 1951, in the English language in two copies.
