NOTE¹ BY WHICH THE GOVERNMENT OF THE No. 1432. UNITED KINGDOM OF GREAT BRITAIN AND NORTH-ERN IRELAND, IN PURSUANCE OF ARTICLE 8 OF THE OF PEACE² WITH BULGARIA, NOTIFIED TREATY THE BULGARIAN GOVERNMENT OF ITS DESIRE TO ANGLO-BULGARIAN MONEY ORDER REVIVE THE SIGNED AT LONDON ON 7 MAY 1925 AGREEMENT³, AND AT SOFIA ON 7 JUNE 1925. SOFIA, 13 MARCH 1948

His Majesty's Legation at Sofia to the Bulgarian Ministry for Foreign Affairs

His Britannic Majesty's Legation present their compliments to the Bulgarian Ministry for Foreign Affairs and with reference to Article 8 of the Peace Treaty with Bulgaria have the honour to notify the Bulgarian Government that His Majesty's Government in the United Kingdom desire to keep in force or revive the following pre-war bilateral agreement in respect of the United Kingdom of Great Britain and Northern Ireland and those other territories for which His Majesty's Government in the United Kingdom are internationally responsible, and to which the under-mentioned bilateral agreement applied at the time of the outbreak of war :---

Agreement for the exchange of Money Orders signed in London on 7th May, 1925, and in Sofia on 7th June, 1925.²

2. It is His Majesty's Government's understanding that notification of the above agreement under the terms of the Treaty of Peace in no way prejudices the right of either of the two Governments to revise it. It is also understood that any of the provisions of the agreement which may be found not to be in conformity with the Treaty of Peace shall be considered to have been deleted in so far as the application of the Treaty of Peace is concerned, but shall be regarded as being in full force with regard to matters not covered by the Treaty of Peace.

3. In accordance with paragraph 2 of Article 8 of the Treaty of Peace, His Majesty's Government will register with the Secretariat of the United Nations the agreement which is to be revived.
