Your Excellency :

In accordance with the stipulations of Article 3 of the contract between the Government of the United States and that of Peru, governing the services of the American Naval Mission in Peru,² I have the honor to advise Your Excellency of the desire of my Government to renew the said contract for another term. The present contract will expire on July 31 of this year, and according to its provisions, it must be renewed six months in advance of its date of expiry.

I will appreciate it, therefore, if Your Excellency will take the necessary steps to effect the renewal thereof.

Please accept, Your Excellency, the renewed assurances of my highest consideration.
