Your Excellency :

I refer to the recent conversations between Colonel Guillermo Suero, Air Attaché to this Embassy, and the proper officers of the War Department. I have the honor to confirm the intentions of my Government to extend the existing aviation agreement between the United States Government and the Peruvian Government, which is due to expire on July 31st, 1946, for another month; that is, until August 31st, 1946.

If it is in accordance with the wishes of Your Excellency, this note and the reply may be considered as the legal instrument of the completion of the extension of the existing aviation agreement.

Please accept, Your Excellency, the renewed assurances of my highest consideration.

I refer to the Embassy's note of July 24, 1946, in which is requested the renewal for a period of one month of the Agreement entered into on July 31, 1940 and extended for a period of two years by exchange of notes,¹ dated January 31, February 18, April 6 and 29, and May 2, 1944, between the Governments of the United States of America and the Republic of Peru, providing for the assignment of a United States Naval Aviation Mission to Peru.

In this connection, I am pleased to inform you that the renewal of the Agreement for a period of one month, effective July 31, 1946, is agreeable to the Government of the United States of America.

Your Excellency :

I refer to the note of this Embassy dated July 24th⁴ regarding the extension of the existing aviation agreement between the United States Government and the Peruvian Government for one more month, extended from July 31st until August 31st of 1946, and to the acceptance of this renewal by the Department in its note of August 9, 1946.

At this time, I wish to inform you that the negotiations for the other agreement have not been completed and signed as yet; therefore, I have the honor to request that the present agreement be extended for one more month in order to expire on September 30, 1946 instead of on August 31, 1946.

Please accept, Your Excellency, the renewed assurances of my highest consideration.
