AGREEMENT<sup>1</sup> BETWEEN THE WORLD HEALTH ORGANIZATION AND THE GOVERNMENT OF COLOMBIA FOR THE EXTENSION OF THE PROVISIONS OF THE BASIC TECHNICAL ASSISTANCE AGREEMENT<sup>2</sup> SIGNED ON 24 NOVEMBER 1950 BETWEEN THE ORGANIZATIONS MEMBERS OF THE TECHNICAL ASSISTANCE BOARD AND THE GOVERNMENT OF COLOMBIA. SIGNED AT BOGOTA, ON 18 SEPTEMBER 1951, AND AT WASHINGTON, ON 10 OCTOBER 1951

It is hereby agreed that the provisions of the Basic Technical Assistance Agreement signed on 24 November 1950<sup>2</sup> between the United Nations, the Food and Agriculture Organization of the United Nations, the International Civil Aviation Organization, the International Labour Organisation, the United Nations Educational, Scientific and Cultural Organization and the World Health Organization and the Government of Colombia for the provision of Technical Assistance shall be deemed to extend to technical advisory assistance furnished to the Government of Colombia by the World Health Organization and financed from the funds of the World Health Organization other than those made available under the Expanded Programme of Technical Assistance for Economic Development.

DONE at Bogotá this 18 day of September 1951 and at Washington, D.C., this 10 day of October 1951.
