No. 1531. AGREEMENT<sup>1</sup> BETWEEN THE FEDERAL PEOPLE'S REPUBLIC OF YUGOSLAVIA AND THE PEOPLE'S REPUBLIC OF ALBANIA REGARDING A CREDIT OF 2,000 MILLION DINARS TO BE USED FOR THE ECONOMIC REHABILITATION AND DEVELOPMENT OF THE PEOPLE'S REPUBLIC OF ALBANIA. SIGNED AT BELGRADE, ON 12 JUNE 1947

*Article 1*

Desirous of contributing to the creation of the necessary conditions for the co-ordination of the economic plans of the allied countries for the People's Republic of Albania and the Federal People's Republic of Yugoslavia and of providing material support to enable Albanian economic and industrial recovery to attain an adequate level, the Government of the Federal People's Republic of Yugoslavia grants assistance in the form of a credit to the Government of the People's Republic of Albania.

*Article 2*

For the purposes set forth in article 1 of this Agreement, the Government of the Federal People's Republic of Yugoslavia grants to the Government of the People's Republic of Albania a credit to the amount of 2,000 million dinars for 1947.

*Article 3*

The above credit shall be granted in the form of commodities, materials and services necessary for investments and works in connexion with the economic reconstruction and development of the People's Republic of Albania, and in the form of widely consumed commodities.

*Article 4*

The term and repayment conditions of the credit shall be determined by a subsequent agreement between the two Governments.

*Article 5*

The Government of the People's Republic of Albania and the Government of the Federal People's Republic of Yugoslavia shall also determine, by special

protocols, the kinds of commodities and investments, the volume of purchases, the method of delivery and any other necessary matters in connexion with the deliveries referred to in article 3 of this Agreement.

*Article 6*

This Agreement shall enter into force on the day of its signature.

DONE at Belgrade on 12 June 1947, in French, in duplicate, one copy to be retained by each of the Contracting Parties.
