No. 1606. AGREEMENT<sup>1</sup> BETWEEN THE UNITED NATIONS AND THE GOVERNMENT OF INDIA ON THE ORGANIZATION IN INDIA OF A SEMINAR ON THE PRODUCTION AND USE OF POWER ALCOHOL. SIGNED AT BANGKOK, ON 26 NOVEMBER 1951, AND AT NEW DELHI, ON 12 JANUARY 1952

The United Nations (hereinafter referred to as "the Organization") and the Government of India (hereinafter referred to as "the Government"), considering the provisions of General Assembly Resolution 200 (III),<sup>2</sup>

Have agreed as follows :

*Article I*

The Organization accepts the offer of the Government of India to act as the host country for a Seminar on the Production and Use of Power Alcohol (hereinafter referred to as "the Seminar") to be held at such a location, and during such a period in the year 1952, as may be mutually agreed upon. The Organization undertakes to provide the services of three experts in the field of the production and use of power alcohol, an Executive Secretary for the Seminar and one other professional officer to assist in its conduct (hereinafter referred to as "the United Nations personnel"). The governments of various countries in the Asian and Far Eastern region shall be entitled to participate in the Seminar and to nominate such individuals to attend it as they may deem desirable, subject to provisions of paragraph 2 of Article III.

*Article II*

1. The Organization will, in respect of the organization and conduct of the Seminar, defray the following costs :—

- (a) The salaries of the United Nations personnel;
- (b) The cost of transportation, and other necessary travel expenses of the United Nations personnel from their place of recruitment to the location of the Seminar and back;

- (c) Subsistence allowance during travel and during the stay of the United Nations personnel in India, as well as displacement allowance where applicable;
- (d) Insurance of the United Nations personnel; and,
- (e) Any other expenses incurred outside the country and necessary for the efficient conduct of the Seminar.

2. The Government will assume responsibility for the following costs involved in the organization of the Seminar :—

- (a) Transportation of the United Nations personnel and of equipment and supplies within the country in connection with the organization of the Seminar, and all official telephone, telegraph, postal and other communication expenses;
- (b) Medical care and hospitalization for the United Nations personnel;
- (c) Any taxes or other duties or levies collected by the Government not covered by the privileges and immunities under Article III.

3. The Government shall also provide to the Organization, after consultation therewith :—

- (a) Adequate office facilities, office supplies and equipment, as well as suitable facilities for the holding of lectures, discussions, etc.;
- (b) The necessary local secretarial and related assistance, including :
  - One Liaison Officer for two months,
  - One Administrative Assistant and Documents Officer for one month,
  - One Secretary for two months,
  - One Secretary for one month,
  - And such Interpreters and/or Translators as may be required;
- (c) Any other facilities mutually agreed upon, including the making of the necessary arrangements for participants in the Seminar to visit such industrial organizations concerned with the production and use of power alcohol as may be mutually agreed upon.

The Government will assume all administrative and financial responsibilities related to the provision of the facilities specified in this paragraph.

4. For the purpose of meeting its obligations under paragraph 2 above, the Government shall establish, maintain and place at the disposal of the Organization a local currency fund in the amount of Rs. 1500 (Rupees one

thousand and five hundred). Any unused balance shall be returned to the Government after due rendering of accounts.

5. In lieu of making payment in accordance with paragraph 2 above, the Government may give supplies and services in kind to the extent that may be mutually agreed upon.

### *Article III*

1. The Government shall accord to the United Nations personnel and their property and assets, while in the country, the privileges and immunities normally granted under the Convention<sup>1</sup> on the Privileges and Immunities of the United Nations, and shall issue any necessary administrative instructions to this end.

2. The Government, further, shall, subject to the provision of adequate information by the Organization, facilitate the attendance of such participants from other countries in the Asian and Far Eastern region as may be agreed upon between the Organization, the Government of India, and the governments of the countries concerned.

### *Article IV*

1. This Agreement shall come into force upon signature.

2. This Agreement may be modified by agreement between the Organization and the Government, each of which shall give full and sympathetic consideration to any request by the other for such modification.

3. This Agreement may be terminated by either party upon written notice to the other, and shall terminate sixty days after receipt of such notice.

IN WITNESS WHEREOF the undersigned, duly appointed representatives of the Organization and the Government have, on behalf of the Parties, signed this Agreement at Bangkok and New Delhi respectively, this 26th day of November 1951 and this 12th day of January 1952, in the English language in four copies.
