AGREEMENT BETWEEN THE UNITED STATES OF AMERICA AND THE REPUBLIC OF HAITI FOR THE TERMINATION OF THE TRADE AGREEMENT OF MARCH 1935. 2 SIGNED AT PORT-AU-PRINCE, ON 29 DECEMBER 1949

The Governments of the United States of America and the Republic of Haiti, Having undertaken tariff negotiations directed toward the accession³ of the Republic of Haiti to the General Agreement on Tariffs and Trade, 4

Hereby agree that the Trade Agreement between the United States of America and the Republic of Haiti, signed on March 28, 1935 and supplemented by numbered paragraphs 1 and 2 of an Exchange of Notes of April 25, 1942, 5 shall terminate when (1) the Republic of Haiti becomes a contracting party 6 to the General Agreement on Tariffs and Trade as defined in Article XXXII thereof and (2) all the concessions which were initially negotiated with Haiti and are provided for in Schedule XX contained in Annex A to the Annecy Protocol of Terms of Accession to the General Agreement on Tariffs and Trade 7 enter into force. 8

In witness whereof the representatives of the Government of the United States of America and the Republic of Haiti have signed this Agreement.

DONE in duplicate, in the English and French languages, both equally authentic, at Port-au-Prince this twenty-ninth day of December, one thousand nine hundred and forty-nine.
