No. 1790. EXCHANGE OF NOTES CONSTITUTING AN ARRANGEMENT¹ BETWEEN BELGIUM AND PAKISTAN REGARDING THE RECIPROCAL EXTRADITION OF FUGITIVE CRIMINALS. BRUSSELS, 23 JANUARY AND 20 FEBRUARY 1952

The Embassy of Pakistan present their compliments to the Ministry of Foreign Affairs and have the honour to invite the Ministry's attention to the Treaty of Extradition concluded on 29th October, 1901,² between the United Kingdom and Belgium for the mutual surrender of fugitive criminals, to which the late Government of India was also a party.

Since the partition of the subcontinent of India in 1947, the aforesaid Treaty has devolved on the Government of Pakistan, who wish to ascertain whether the Government of Belgium consider the provisions of the above-mentioned Treaty, as supplemented and amended by the Conventions of 5th March 1907³ and 3rd March 1911,⁴ respectively, binding between Belgium and Pakistan.

The Embassy of Pakistan avail themselves of this opportunity to renew to the Ministry of Foreign Affairs the assurance of their highest consideration.

The Department of Foreign Affairs has the honour to inform the Embassy of Pakistan at Brussels in reply to its note F42/52/2 of 23 January 1952 that the Belgian Government considers that the Treaty of Extradition concluded on 29 October 1901 between Belgium and the United Kingdom as supplemented and amended by the Conventions of 5 March 1907 and 3 March 1911, respectively, may be considered as binding in such matters between Belgium and Pakistan, the two Governments being in agreement on this matter.

The present note and the above-mentioned note from the Legation shall be regarded as evidence of this agreement.
