In order to simplify the formalities of granting visas for Pakistan or Turkey to citizens of both countries bearing valid diplomatic, service, special or ordinary passports, and with reference to the exchange of views which took place between the Ministry of Foreign Affairs and Commonwealth Relations and the Turkish Embassy, this Embassy, upon instructions from its Government, has the honour to propose to the Ministry of Foreign Affairs and Commonwealth Relations, the adoption of the following arrangement:

1. Entry and transit visas for the respective countries shall be granted without preliminary application for authorisation, wherever such a visa may be requested from the competent authorities in foreign countries, by citizens of the two countries in possession of diplomatic, service, special and ordinary passports.

Before filing an application for transit visa, the interested parties must have previously obtained the visa of the country of destination and that of the country through which they will travel immediately after leaving the territory of the country for which the transit visa is requested.

2. An entry visa shall entitle the holder to a sojourn of three months which, however, may be extended by the competent authorities of the country of sojourn, should such an application be made by the interested party, giving reasons for his desire to prolong his stay, and provided the authorities find such reasons acceptable.

It is always understood that the above clause does not apply to members de carrière or the Diplomatic Missions and Consular Services of each of the two parties called upon to fulfil their duties in the territories of the other party.

- 3. A transit visa shall entitle the holder to the rights granted by such a visa in accordance with the relative rules in force in each of the two countries.
- 4. In doubtful cases, the authorities requested to grant a visa shall have the right to make a preliminary application to their Government for authorisation to grant the visa.
- 5. It is understood that each of the parties reserves the right to make any modifications in the above-defined system as may be deemed necessary, provided that timely notice is given to the other party.
- 6. Each party shall take the necessary steps in order to ensure the entry into force of the above-mentioned arrangement, on the thirtieth day after the date on which the Ministry of Foreign Affairs and Commonwealth Relations communicates its agreement to the Turkish Embassy.

Hoping to receive a favourable answer, the Embassy renews to the Ministry of Foreign Affairs and Commonwealth Relations the assurances of its highest consideration.
