Bagdad, May 22, 1952

Your Excellency,

In accordance with instructions received from Her Majesty's Principal Secretary of State for Foreign Affairs, I have the honour to inform your Excellency that Her Majesty's Government in the United Kingdom of Great Britain and Northern Ireland have had under consideration a proposal of the Royal Iraqi Government for the transfer to the Iraqi Government of certain property in the Port of Basra at present held by Her Majesty's Government, in consideration of the final settlement of the debt owing to Her Majesty's Government in respect of this property. Her Majesty's Government are prepared to agree to this proposal on the terms set out below, notwithstanding the fact that the conditions for the transfer of the Basra Port property laid down in paragraph 5 of the separate agreement on financial questions embodied in the Notes exchanged in London on 19th August, 1930,² which agreement was included in the instrument of ratification of the Treaty of Alliance signed at Bagdad on 30th June, 1930,³ have not yet been fulfilled.

The Royal Iraqi Government having paid the amount outstanding on the Basra Port debt, Her Majesty's Government will now undertake with the competent Iraqi authorities the necessary formalities for the re-registration in the name of the Royal Iraqi Government of all the Port properties included in the attached list and such other properties as may appear later to have been omitted from this list for one reason or another. These properties will not include those registered

in the name of the British Colonial Minister and his Secretary comprising the Indian Cemetery, serial No. 11/1, the Indian Crematorium, serial No. 11/2, land serial No. 10/2, and the cantonment, serial No. 10/1, registered *in tapu* in May 1926 and March 1930. The re-registration will take place on the understanding that—

- (a) The Royal Iraqi Government accept full responsibility for any claims and liabilities relating to the properties to be re-registered, which have already arisen or may arise in the future;
- (b) the Royal Iraqi Government will meet any dues, charges and expenses incidental to the transfer and re-registration of the property.

If the Royal Iraqi Government agree with the foregoing, I have the honour to suggest that this present Note and your Excellency's reply in that sense shall be regarded as constituting an agreement between our two Governments, superseding the provisions of paragraph 5 of the separate financial agreement of 19th August, 1930, ¹ and coming into force on the date on which the Royal Iraqi Government shall inform Her Majesty's Government in the United Kingdom that it has been ratified by the legislature of Iraq.
