EXCHANGE OF LETTERS CONSTITUTING AN AGREEMENT¹ BETWEEN BELGIUM AND ITALY FOR RECIPROCAL TREATMENT IN THE GRANT OF TOTAL EXEMPTION FROM IMPORT DUTIES IN RESPECT OF GOODS INTENDED FOR THE PERSONAL USE OF ESTABLISHED CONSULAR OFFICIALS AND OF EMBASSY EQUIPMENT. ITALIAN EMBASSY IN BELGIUM

Your Excellency,

I have the honour to apprise you of the following:

Under Italian legislation as at present in force total exemption from import duty may be granted, subject to reciprocity, for the import of goods as follows:

- 1. Goods imported direct and intended for the personal use of established Belgian consulate officials holding office in Italy provided that the persons concerned have come from abroad, are Belgian nationals, do not pursue any gainful employment outside their official functions, provided also that notification of their appointment has been sent to the Italian Government through the diplomatic channel and that they have been properly authorized to carry out their mission;
- 2. Embassy equipment sent by the Belgian Government, or on its behalf, to its established or unpaid consular staff in Italy. It is to be understood that:
- (a) goods means all articles and commodities without exception imported direct from abroad, taken out of a warehouse placed under customs supervision or imported into Italy under the transit system;
- (b) established consular officials means all consular officials of the rank of Consul-General, Consul or Vice-Consul;

- (c) personal use means use by the official concerned and the members of his household (wife and unmarried children under age living in the same house);
 - (d) Embassy equipment means:
 - (1) official emblems (flags, seals, coats of arms and other articles of the same kind);
 - (2) official documents (Embassy records, and documents of all kinds provided they bear a stamp giving them an official character);
 - (3) office furniture (desks, tables, chairs, cupboards, safes, typewriters and calculating machines, carpets, curtains, blinds, etc);
 - (4) office supplies (paper, envelopes, notebooks, scissors, pencils, pens, india rubbers, blotters, string, ink, paper-clips, etc.).

Needless to say, established Belgian consular officials may, upon arrival to take up their posts, bring in free from all taxes and duties, personal possessions of all kinds which bear clear evidence of use.

On the understanding that total exemption from import duties as set forth above can be granted only subject to reciprocity, I beg you to inform me whether the Belgian Government is prepared to grant the same privileges to consular officials of the Italian Republic holding posts in Belgium.

Should that be so, the present Note and your reply shall be regarded as forming an agreement between our two Governments in this matter, as set forth above.

Unless you have any objection, such privileges might also be granted in respect of protectorates, colonies, possessions or overseas territories owing allegiance to or under the authority of the Contracting Parties.

Your Excellency,

I have the honour to acknowledge receipt of your letter No. 3014 of 8 September, in which you were so good as to inform me that your Government is prepared to grant, subject to reciprocity, total exemption from import duties as follows:

- 1. Goods imported direct and intended for the personal use of established Belgian consulate officials holding office in Italy provided that the persons concerned have come from abroad, are Belgian nationals, do not pursue any gainful employment outside their official functions, provided also that notification of their appointment has been sent to the Italian Government through the diplomatic channel and that they have been properly authorized to carry out their mission;
- 2. Embassy equipment sent by the Belgian Government, or on its behalf, to its established or unpaid consular staff in Italy.

 Accordingly:
- 1. All established Italian consular officials holding office in Belgium shall henceforth enjoy exemption from the payment of import duties on goods intended for their personal use provided that they are in the same position as established Belgian consular officials holding office in Italy, to whom this exemption has been granted;
- 2. Embassy equipment sent by the Italian Government, or on its behalf, to its consulates in Belgium, shall henceforth enjoy exemption from the payment of import duties.

The privileges mentioned in your letter with regard to the admission of personal possessions of all kinds bearing clear evidence of use, shall be granted under the same conditions to established Italian consular officials upon arrival to take up their posts.

It is understood that your Note and this reply shall be regarded as forming an agreement between our two Governments in this matter, as set forth above. These privileges shall also be granted in respect of protectorates, colonies, possessions or overseas territories owing allegiance to or under the authority of the Contracting Parties.

These provisions may be denounced or modified should one of the Parties so desire.
