Sir.

I have the honour to make further reference to your letter No. 712/L of 13 July 1951 regarding the Agreement concerning Documents of Identity of members of air crews concluded between Belgium, the United Kingdom, Australia, New Zealand and India on 29 April 1938.²

I am now in a position to state that the New Zealand Government is willing to terminate bi-lateral agreements concerning Documents of Identity of Members of Air Crews in those cases where the country concerned has accepted, without reservation, paragraphs 3.10 and 3.11 of Annex 9 of the International Civil Aviation Convention.

I understand that the United Kingdom Government has approached the Belgian authorities, suggesting that the Agreement embodied in the Exchange of Notes of 1938 should lapse with respect to the United Kingdom and colonial

territories. I would therefore propose that, as from the date on which you advise me that the Belgian Government has accepted unconditionally paragraphs 3.10 and 3.11 of Annex 9, the 1938 Agreement should lapse with respect to New Zealand.

In due course I should appreciate hearing from you whether the Government of Belgium is in agreement with this proposal.

I have the honour to refer to your letters of 5th February, 1953 and 31st August, 1953 (P.M. 110/16/2), regarding the termination of the Agreement concerning Documents of Identity of Members of Air Crews concluded between Belgium, the United Kingdom, Australia, New Zealand and India on 29th April, 1938.

In this connection, I wish to bring to your notice that both Belgium and the Belgian Congo enforce the provisions of Paragraphs 3.10 and 3.11 of Annex 9 to the Chicago Convention on Civil Aviation under reserve of reciprocity.

As far as New Zealand is concerned, Belgium is prepared to let lapse the 1938 Agreement, accepting therefore, the proposal embodied in your letter of 5th February, 1953.
