The Australian Legation presents its compliments to the Ministry of Foreign Affairs of Viet Nam and has the honour to propose an exchange of official documents between Viet Nam and Australia on the following basis :

The Ministry of Foreign Affairs of Viet Nam will undertake to despatch regularly and as soon as practicable after publication to the Librarian, Commonwealth National Library, Canberra, A.C.T., Australia, the Viet Namese documents named on the list attached as appendix "A". In return, the Librarian of the Commonwealth National Library will undertake to despatch regularly and as soon as practicable after publication to the Ministry of Foreign Affairs of Viet Nam the Australian publications listed in Appendix "B". The composition of these lists may be altered by mutual agreement at any time. Each of the two Governments shall bear all charges for the transportation within its own country of the publications of both Governments, and the shipment of its own publications to a place reasonably convenient to the exchange office of the other Government.

If the Ministry of Foreign Affairs agrees with this proposal, the Legation suggests that this Note and the Ministry's confirmatory reply should be deemed to record an agreement between the two Governments, having retroactive effect from 1st January, 1954.

The Australian Legation takes the opportunity of expressing to the Ministry of Foreign Affairs the renewed assurances of its high consideration.

The Ministry of Foreign Affairs of Viet-Nam undertakes to despatch regularly and as soon as practicable after publication to the Commonwealth National Library at Canberra (Australia) the Viet-Namese documents named on the list attached as appendix "A".

In return, the Commonwealth National Library undertakes to despatch regularly and as soon as practicable after publication to the Ministry of Foreign Affairs of Viet-Nam the Australian publications listed in the attached appendix "B".

The composition of these lists may be altered by mutual agreement at any time.

Each Government shall bear all charges for the despatch of its own publications to a place designated as the exchange office of the other Government.

The present note and the Legation's aforesaid note constitute an exchange of notes recording an agreement between the Australian and Viet-Namese Governments, having retroactive effect from 1 January 1954.
