No. 2511. COMMERCIAL AGREEMENT<sup>1</sup> BETWEEN GREECE AND FRANCE. SIGNED AT ATHENS, ON 23 DECEMBER 1952

The Government of the Kingdom of Greece and the Government of the French Republic, being desirous of regulating and facilitating the development of commercial exchanges between the two countries, have agreed as follows:

#### Article 1

The exchange of goods between France and Greece shall be effected in the following manner:

The French authorities shall issue import licences for the Greek products, whether subject to quota in France or classed in France as ex-decontrolled non-essentials, referred to in schedule B annexed hereto in the amounts or in the value stated therein. Nevertheless, allocations under a part of this schedule may be withheld until 1 July.

Greek products regarded as essential in France shall be imported under the French general import programme.

The Greek authorities shall issue licences for the import of French products which are not included in the Greek general import programme and appear in schedule A annexed hereto. Nevertheless, allocations under a part of this schedule may be withheld until 1 July.

French products included in the Greek general import programme shall be imported in accordance with the regulations in force in Greece.

#### Article 2

The two Governments shall take appropriate administrative measures to facilitate the full implementation of the programme of exchanges contemplated by this Agreement.

In addition, the competent authorities of both countries shall give favourable consideration to any import or export applications submitted to them in respect of goods and values not referred to or stated in the said schedules.

The seasonal character of the goods shall be taken into account, as appropriate, in the granting of import and export licences.

#### Article 3

The settlement of the imports and exports between the two countries shall continue to be effected in accordance with the provisions of the Payments Agreement of 24 April 1946 in so far as the said provisions are consistent with the system instituted under the Agreement for the Establishment of a European Payments Union, dated 19 September 1950.

#### Article 4

For the purpose of issuing import and export licences, the competent authorities of the two countries shall not apply any regulations more severe than those applied with respect to any other country.

#### Article 5

At the end of the first six months, or at any time at the request of either of the two Governments, a Joint Commission shall consider the conditions of operation of this agreement and any possible improvements.

#### Article 6

The provisions of the present Agreement shall be applicable to the territories included in the franc area.

#### Article 7

This Agreement, which supersedes the Commercial Agreement signed in Paris on 3 July 1951, shall enter into force on 1 January 1953 and shall remain operative for one year.

## PROTOCOL ANNEXED TO THE AGREEMENT BETWEEN FRANCE AND GREECE OF 23 DECEMBER 1952

- I. If reciprocal exports are seriously threatened or the terms of the Agreement are modified as a result of measures taken by either Government, the Contracting Parties shall immediately enter into consultations with a view to examining the situation so created and means of remedying it.
- II. The tonnages of tobacco shall be allotted according to the dates of orders placed by the S.E.I.T.A.
- III. Tractors of French origin shall be imported under the same conditions as tractors originating in other countries; import licences applied for shall be issued in accordance with the procedure adopted by the Ministry of Industry. This procedure is similar to the CI procedure.
- IV. During the term of the Agreement, export authorizations shall be granted by the competent French authorities for fifteen (15) tons of calf-skins of Metropolitan French origin.

V. The French delegation takes note of the declaration by the Greek delegation that the importation of goods under the CI procedure as formulated in the present import programme is not restricted through shortage of credit.

With a view to avoiding any dispute concerning the interpretation of the programme, a list of certain French export products, with the relevant Greek import programme item numbers opposite, shall be drawn up at a later date.

VI. Each Government undertakes to open a quota of 70,000,000 (seventy million) francs, which shall be reserved for exhibitors taking part in the international fairs of each of the two countries.

The allocation of the said quotas by products shall be effected by agreement between the two Governments.

VII. The procedure for the importation of Samos wine into France shall be subject to special regulations which shall be established by agreement between the two Governments.
