No. 2513. TRADE PROTOCOL BETWEEN GREECE AND DENMARK. SIGNED AT COPENHAGEN. ON 15 SEP-TEMBER 1952

In conformity with Article VIII of the Trade Agreement of 25 February 1949² between the Royal Government of Greece and the Royal Government of Denmark, the delegations of the two countries met at Copenhagen from 8 to 15 September 1952 for the purpose of examining the progress of trade relations between the two countries. The two delegations agreed as follows :

Article 1

The Trade Agreement² and the Payments Agreement³ of 25 February 1949 between the Royal Government of Greece and the Royal Government of Denmark, as amended by this Protocol shall remain in force until 24 August 1953. The Agreements shall be renewed for successive periods of one year unless denounced by one of the two Governments three months before the date of their expiry.

Article 2

Trade in quota goods between the two countries during the period from 25 August 1952 to 24 August 1953 shall be carried on in accordance with the following provisions :

(a) Greek exports of quota goods to Denmark shall be effected on the basis of the list annexed to this Protocol.

(b) Danish exports to Greece shall be effected on the basis of the Greek import programme. The Greek Government shall grant, in conformity with the Greek regulations in force, import licences for Danish goods without discrimination with respect to the other countries members of the European Payments Union.

Article 3

The two Governments shall apply any release from restriction effected or to be effected in conformity with the decisions of the O.E.C. to goods originating in or coming from both countries. Accordingly, any release from restriction

effected or to be effected in conformity with the said decisions shall automatically apply to goods originating in or coming from Denmark and Greece respectively.

Article 4

This Protocol shall come into force on the date of signature with retroactive effect from 25 August 1952, and shall remain in force for one year.
