The Imperial Iranian Embassy at Karachi present their compliments to the Ministry of Foreign Affairs and Commonwealth Relations, Government of Pakistan, and according to the information received by them from the Ministry of Foreign Affairs of Iran, they have the honour to state that the Iranian Cabinet have agreed that on the basis of reciprocity and in order to accord the travelling facility, the Foreign Missions of Iran in Pakistan may issue gratis visas to the people of their friend and neighbour Government of Pakistan.

2. The Ministry of Foreign Affairs of Iran have intimated their above decision to the Pakistan Embassy in Iran at Teheran and are awaiting the reply of the Government of Pakistan. The Imperial Iranian Embassy at Karachi, shall, therefore, feel grateful to the Ministry of Foreign Affairs and Commonwealth Relations, Government of Pakistan, if they kindly arrange to intimate to them the decision of their Government, in the matter, at an early date.

3. The Imperial Iranian Embassy at Karachi avail themselves of this opportunity to renew to the Ministry of Foreign Affairs and Commonwealth Relations, Government of Pakistan, the assurances of their highest consideration.
