EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN THE GOVERNMENT OF PAKISTAN AND THE GOVERNMENT OF THE REPUBLIC OF TURKEY REGARDING GRANT OF MULTIPLE JOURNEY VISAS TO HOLDERS OF TURKISH DIPLOMATIC, SERVICE AND SPECIAL PASSPORTS AND PAKISTAN DIPLOMATIC AND ORDINARY PASSPORTS ENDORSED "OFFICIAL". KARACHI, 20 SEPTEMBER AND 5 AND 22 OCTOBER 1951

The Ministry of Foreign Affairs and Commonwealth Relations present their compliments to the Embassy of the Republic of Turkey in Pakistan and have the honour to say that the Government of Pakistan are prepared to conclude with the Government of Turkey an Agreement in the following terms:—

- (1) Holders of valid Turkish diplomatic service and special passports will be granted multiple journey visas by the Government of Pakistan ;
- (2) Holders of valid Pakistan diplomatic, and ordinary passports endorsed "Official" will be granted multiple journey visas by the Government of Turkey;
- (3) The initial visas granted on valid Turkish diplomatic, service and special passports, issued to members of the diplomatic missions of the Republic of Turkey in Pakistan and their families, will be valid for multiple journeys to Pakistan during the entire tenure of their office;

- (4) The initial visas granted on valid Pakistan diplomatic and ordinary passports endorsed "Official" issued to members of the diplomatic missions of Pakistan in Turkey and their families, will be valid for multiple journeys to Turkey during the entire tenure of their office;
- (5) Holders of valid Turkish diplomatic, service and special passports, visiting Pakistan on non-official business, will be granted visas valid for one year and for multiple journeys; and
- (6) Holders of valid Pakistan diplomatic and ordinary passports endorsed "Official" visiting Turkey on non-official business, will be granted visas for one year and for multiple journeys.

2. If the Government of the Republic of Turkey are prepared to accept the foregoing provisions, the Ministry suggest that the present Note and the Embassy's reply in similar terms should be regarded as embodying and according an Agreement accordingly between the two Governments to take effect on the 15th November, 1951.

3. The Ministry avail themselves of this opportunity, to renew to the Embassy of the Republic of Turkey the assurances of their highest consideration.
