No. 2966. PROTOCOL<sup>1</sup> FOR THE TERMINATION OF THE BRUSSELS AGREEMENTS FOR THE UNIFICATION OF PHARMACOPOEIAL FORMULAS FOR POTENT DRUGS. SIGNED AT GENEVA, ON 20 MAY 1952

Whereas the publication by the World Health Organization of the Pharmacopoea Internationalis has rendered generally obsolete the provisions of the Agreements signed at Brussels on 29 November 1906<sup>2</sup> and 20 August 1929<sup>3</sup> for the Unification of Pharmacopoeial Formulas for Potent Drugs;

The States parties to this Protocol have agreed to the following provisions:

### Article 1

Notwithstanding Article 6 of the Agreement of 29 November 1906 and Article 41 of the Agreement of 20 August 1929, the Parties to this Protocol

2) The Government of the United Kingdom of Great Britain and Northern Ireland declare that their acceptance of the present Protocol does not apply to any of the territories for whose international relations they are responsible but that they reserve the right to extend its application to, and to terminate it separately in respect of, any of the aforesaid territories.

agree that, as between themselves, and as between each State and the World Health Organization, the following international agreements:

- a) Agreement for the Unification of Pharmacopoeial Formulas for Potent Drugs, signed at Brussels on 29 November 1906;
- b) Agreement revising the Agreement respecting the Unification of Pharmacopoeial Formulas for Potent Drugs, signed at Brussels on 20 August 1929; shall cease to have effect.

The Parties to this Protocol therefore propose to replace the provisions contained in the 1906 and 1929 Agreements, at the earliest possible moment and insofar as is compatible with their national legislations, by the corresponding provisions as established by the Pharmacopoea Internationalis and adopted by the World Health Organization.

### Article 2

The Parties to this Protocol further agree. as between themselves, and as between each State and the World Health Organization, that any fonctions previously entrusted, under the provisions of the Agreements listed in Article 1, to the Permanent International Pharmacopoeial Secretariat, shall, after the entry into force of this Protocol and insofar as the exercise of such functions continues to be required, be exercised by the World Health Organization.

## Article 3

Any State party to either or both of the Agreements listed in Article I which is not a signatory to this Protocol may at any time accept this Protocol by sending an instrument of acceptance to the Belgian Government who will inform all signatory and other governments which have accepted this Protocol and the World Health Organization of such accession.

## Article 4

States may become Parties to this Protocol by:

- 1) Signature without reservation as to approval;
- 2) Signature subject to approval followed by acceptance; or
- 3) Acceptance.

Acceptance shall be effected by the deposit of a formal instrument with the Belgian Government.

## Article 5

This Protocol shall enter into force when ten States parties to either or both of the Agreements listed in Article 1 have become Parties to this Protocol and thereupon certified true copies shall be transmitted by the Belgian Government to the Secretary-General of the United Nations for registration in accordance with Article 102 of the Charter of the United Nations.

IN FAITH WHEREOF the duly authorized representatives of their respective Governments have signed this Protocol, which is drawn up in the English and French languages, both texts being equally authentic, in a single original which shall be deposited with the Belgian Government.

Authentic copies shall be furnished by the Belgian Government to each of the signatory and accepting States and to any other State which, at the time this Protocol is signed, is a Party to either or both of the Agreements listed in Article 1.

The Belgian Government shall as soon as possible notify each of the Parties to this Protocol and the World Health Organization of its entry into force.

FINAL ACT OF THE MEETING OF THE GOVERNMENTS PARTIES TO THE BRUSSELS AGREEMENTS FOR THE UNIFICATION OF PHARMACOPOEIAL FORMULAS FOR POTENT DRUGS. SIGNED AT GENEVA, ON 20 MAY 1952

A meeting of the Government Parties to the Agreement for the Unification of Pharmacopoeial Formulas for Potent Drugs, signed at Brussels on 29 November 1906, and the Agreement revising the Agreement for the Unification of Pharmacopoeial Formulas for Potent Drugs, signed at Brussels on 20 August 1929, was convened by the Director-General of the World Health Organization at the Palais des Nations in Geneva at 3 p.m. on 12 May 1952.

The representative of Belgium, Dr. P. J. J. van de Calseyde, was elected President of the meeting.

This meeting was held following a resolution of the Executive Board of the World Health Organization, adopted on 1 February 1952 upon advice to that effect given by the Expert Committee on the International Pharmacopoeia of the said Organization, the resolution being in the following terms:

"The Executive Board,

Considering paragraph 3 of Resolution EB8/R/40 requesting the Director-General to prepare regulations, to be adopted in accordance with Article 21

(d) of the Constitution of the World Health Organization, in which the International Pharmacopoeia would be embodied and which would replace the 1929 Brussels Agreement;

Being of the opinion that termination of the Brussels Agreements of 1906 and 1929 would suffice for the time being, the International Pharmacopoeia consequently retaining its present status as a recommendation by the World Health Assembly,

REQUESTS the Director-General to take the steps necessary to conclude, between the States concerned, a Protocol to terminate the Brussels Agreements for the Unification of Pharmacopoeial Formulas for Potent Drugs."

At the meeting of 12 May 1952 the final text of a Protocol ceasing the effects of the Brussels Agreements of 1906 and 1929 was established.

In signing the Protocol, the delegation of the Government of the Netherlands made the following declaration:

"The Netherlands delegation to the Fifth World Health Assembly, of opinion that the Agreement for the Unification of Pharmacopoeial Formulas for Potent Drugs, signed at Brussels on 29 November 1906 and the Agreement revising the Agreement respecting the Unification of Pharmacopoeial Formulas for Potent Drugs, signed at Brussels on 20 August 1929 should not be suspended as long as no Regulation in pursuance of Article 21 (d) of the Constitution of the World Health Organization will have come into force and considering the acceptance by ten States parties to either or both of the Agreements is not a sufficient number for the entry into force of this Protocol, will sign the Protocol for the Termination of the Brussels Agreements for the Unification of Pharmacopoeial Formulas for Potent Drugs ad referendum."

On 20 May 1952 a further meeting was convened in Geneva by the President Dr. P. J. J. van de Calseyde, which was attended by Dr. Brock Chisholm, Director-General of the World Health Organization, and the representatives of the Governments signatories of this Final Act and of the Protocol.

At this meeting the signatures were apposed to the Protocol terminating the Brussels Agreements for the Unification of Pharmacopoeial Formulas for Potent Drugs, after due examination of the credentials of the representatives of the said Governments.

In faith whereof the undersigned delegates have signed this Final Act in Geneva this twentieth day of May One thousand nine hundred and fifty two in
