Dear Mr. Frellesvig,

The Government has had under review the question of visas and visa fees for foreign nationals travelling to or through Israel.

It has been decided that, as a first step towards easing travel barriers, visa fees may be waived in respect of the citizens of certain countries, on condition of reciprocity.

I have been instructed to inform you that from 1 March 1955, or from such other date as may be convenient to your Government, Israel visas are to be issued gratis to Danish nationals, if the Danish Government is prepared, with effect from the same date, to issue visas gratis to nationals of Israel.

If your Government agrees to this proposal, it would be convenient to give to this letter and to your reply the effect of a formal agreement.

Government is ready to make an agreement to the effect of a reciprocal abolition of visa fees for citizens respectively of Denmark and Israel. In order to have the necessary time for instructing the Danish Foreign representatives of this changement, the Danish Government suggests the said agreement to become effective from the 1st May, 1955.

If this date is convenient to the Government of Israel, the Legation permits itself to propose to give to this note and to your reply the effect of a formal agreement.

The Danish Legation avails itself of this opportunity to renew to the Ministry the assurance of its highest consideration.
