Your Excellency,

On behalf and at the instance of the Government of Australia I have the honour to propose, on the understanding that the Royal Hellenic Government have no objection to the establishment in Greece of an Australian Government Migration Office, that in order to enable the Office to function satisfactorily it should be accorded by the Royal Hellenic Government the same rights and privileges as those which are or may be accorded to United Kingdom Consulates established in Greece.

If this proposal is acceptable to the Royal Hellenic Government I have the honour to suggest that the present Note and Your Excellency's reply to that effect shall be regarded as constituting an agreement between the two Governments in this matter.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest esteem.
