Your Excellency,

I have the honour to refer to Article 12 of the Treaty of Peace² with Finland, and, by direction of the Government of the Union of South Africa, to inform Your Excellency that, in accordance with the terms of the above-mentioned Article, the Government of the Union of South Africa desire to keep in force and revive the undermentioned pre-war bi-lateral treaties and agreements between the Union of South Africa and Finland.

2. In accordance with the terms of the same Article of the Treaty of Peace, any provisions of the undermentioned treaties or agreements not in conformity with the Treaty of Peace shall be regarded as being deleted from the treaties or agreements in so far as the application of the Treaty of Peace is concerned.

3. In accordance with the terms of paragraph 2 of the Article, the Union Government will register these treaties and agreements with the Secretariat of the United Nations.

- (i) Treaty between Finland and the United Kingdom for the Extradition of Criminals, signed at London, 30th May, 1924.³
- (ii) Exchange of Notes relating to the accession of certain British Dominions; India and certain British Mandated Territories, to the Treaty between Finland and the United Kingdom for the Extradition of Criminals signed at London, 30th May, 1924, Helsingfors, 14th September, 1925.⁴ In so far as the Notes apply to the Union of South Africa.

4. In accordance with the terms of paragraph 3 of the Article, all other pre-war treaties and agreements between the Union of South Africa and Finland will be regarded as abrogated.
