No. 3117. EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN ISRAEL AND LUXEMBOURG REGARDING THE ABOLITION OF VISAS IN THE CASE OF HOLDERS OF DIPLOMATIC AND SERVICE PASSPORTS. BRUSSELS, 15 OCTOBER 1954, AND LUXEMBOURG, 27 OCTOBER 1954

I

LEGATION OF ISRAEL

The Legation of Israel has the honour to acknowledge receipt of the note dated 24 September 1954 in which the Ministry of Foreign Affairs informed it that the Luxembourg Government agrees to the Israel Government's proposal concerning the abolition of consular visas in the case of holders of diplomatic or service passports.

It thanks the Ministry of Foreign Affairs for its kind communication and has the honour to propose that an agreement should be concluded on the subject as follows :

1. The Government of Israel shall waive visa requirements for entry into, exit from and transit through Israel in the case of Luxembourg nationals furnished with valid Luxembourg passports of the following kinds : *diplomatic, service* and passports "*for persons sent on special missions*";
2. The Luxembourg Government shall waive visa requirements for entry into, exit from and transit through Israel in the case of Israel nationals furnished with valid Israel passports of the following kinds : *diplomatic* and *service*.

On receipt of a reply from the Ministry of Foreign Affairs to the effect that the provisions suggested above are considered acceptable by the Luxembourg Government, the Israel Government will regard the present note together with the note from the Ministry of Foreign Affairs to the Israel Legation in reply as constituting the formal agreement between the two Governments on the subject. The agreement shall enter into force thirty days after the date of the reply of the

Ministry of Foreign Affairs and may be denounced at any time by either of the contracting parties subject to three months' notice.

The Ministry of Foreign Affairs has the honour to acknowledge the receipt of the note dated 15 October 1954 in which the Legation of Israel informed it of the following :

The Ministry of Foreign Affairs has the honour to advise the Luxembourg Government that it agrees to the above provisions. Moreover, the Ministry agrees that the Legation's note together with the present note in reply shall be regarded as constituting the arrangement between the Grand-Duchy of Luxembourg and Israel.

It is understood that the agreement shall enter into force thirty days after the date of the present note and may be denounced at any time by either of the contracting parties subject to three months' notice.
