No. 3118. EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN ISRAEL AND LUXEMBOURG REGARDING THE ABOLITION OF VISA FEES. BRUSSELS, 24 MARCH 1955, AND LUXEMBOURG, 30 MARCH 1955

I

LEGATION OF ISRAEL

The Legation of Israel has the honour to acknowledge receipt of the note dated 15 March 1955 in which the Minister of Foreign Affairs informed it of the agreement in principle of the Luxembourg Government to the proposal of the Minister of Foreign Affairs of Israel that visa fees should be abolished in relations between the Grand Duchy of Luxembourg and the State of Israel.

The Legation of Israel thanks the Ministry of Foreign Affairs for its communication and confirms the Israel Government's agreement to the abolition of visa fees for Luxembourg citizens holding Luxembourg national passports and travelling to Israel.

It suggests that the present note, together with the reply of the Ministry of Foreign Affairs confirming its agreement to the abolition of visa fees for Israel citizens holding Israel national passports and travelling to the Grand Duchy of Luxembourg, should be considered as constituting an agreement between the two Governments. It proposes that this agreement should come into force on 1 May 1955, if that date is acceptable to the Ministry of Foreign Affairs.

The Ministry of Foreign Affairs has the honour to acknowledge receipt of the Legation of Israel's courteous note of 24 March 1955, which reads as follows :

[See note I]

In reply to the foregoing note, the Ministry of Foreign Affairs has the honour to confirm to the Legation of Israel that the Luxembourg Government agrees, on its side, to the abolition of visa fees for Israel nationals holding Israel national passports and travelling to the Grand Duchy of Luxembourg. The Luxembourg Government will therefore consider the note from the Legation of Israel reproduced above and the present reply thereto as constituting an agreement between the two Governments on the matter, which, in accordance with the Legation's proposal, shall come into force on 1 May 1955.
