Excellency,

With reference to the recent Consultations regarding the abolition of the Visa requirement on Passports, I have the honour to inform you that I am now authorised by the Netherlands Government to conclude an Agreement with the Government of Ireland on the following lines :

1. Irish citizens proceeding to the Netherlands shall not be required to obtain a Visa precedent to entry into the Netherlands, provided they hold valid Irish Passports.

2. Netherlands citizens proceeding to Ireland shall not be required to obtain a Visa precedent to entry into Ireland, provided they hold valid Netherlands Passports.

3. It is agreed that the abolition of the Visa requirement on Passports does not dispense Irish citizens and Netherlands citizens, proceeding to the Netherlands and to Ireland respectively from the obligation of complying with the Netherlands and Irish laws and regulations regarding entry, short sojourn, residence or employment of aliens.

4. This Agreement shall not affect the rights of the competent authorities of the two countries to refuse admission to, or expel, any person who may be regarded as undesirable, or who cannot satisfy the said authorities that they comply with the laws and regulations referred to under paragraph (3) above.

5. This Agreement shall not apply to travel to territories outside Europe.

6. This Agreement will come into operation on the fifteenth day of May, ninetcen hundred and forty-seven.

If the Irish Government are prepared to accept the foregoing provisions I have the honour to suggest that the present note and Your Excellency's reply in similar
