Your Excellency,

I have the honour to inform Your Excellency that the Government of the Union of South Africa being desirous of simplifying the existing visa formalities between our respective countries are prepared, on a basis of reciprocity, to enter into a visa Agreement in the following terms :

(1) The Government of the Union of South Africa will order all visas to be issued gratis to citizens of Finland intending to visit the Union of South Africa or South West Africa for *bona fide* vacation or business purposes.

(2) The Government of Finland will order all visas to be issued gratis to citizens of the Union of South Africa intending to visit Finland for *bona fide* vacation or business purposes.

(3) These visas shall be made valid for one year from the date of issue and for multiple entries during the period of validity of the visa.

(4) This Agreement shall not exempt South African citizens or Finnish citizens from the obligation of complying with the requirements applicable in respect of admission, residence and employment on entering Finland and South Africa respectively.

(5) Persons who are not able to satisfy immigration or police authorities of their compliance with the abovementioned requirements are liable to be refused admission on arrival.

I therefore have the honour to propose that this Note, together with Your Excellency's confirmation thereof, shall be regarded as an Agreement which shall

be binding until further notice and that the arrangements shall come into operation thirty days after the date of this exchange of Notes.
