The Italian Consulate presents its compliments to the Minister of State of the Principality of Monaco and has the honour to inform him that the Italian Government is prepared to grant Monacan nationals, on a reciprocal basis, the same privileges as are accorded to French nationals pursuant to the Agreement between Italy and France of 28 February 1957 on the movement of persons, a copy of which is attached hereto.<sup>3</sup>

The Department of Foreign Affairs presents its compliments to the Italian Consulate and has the honour to acknowledge receipt of its Note of 28 May 1957, in which it is stated that the Italian Government is prepared to grant Monacan nationals, on a reciprocal basis, the same privileges as are accorded to French

nationals pursuant to the Agreement between Italy and France of 28 February 1957 on the movement of persons.

The Government of the Principality, for its part, is prepared to grant Italian nationals the same privileges in the matter of entry into Monacan territory as are enjoyed by Monacan nationals seeking to enter Italian territory.

These provisions may be applied as of 15 June 1957, the above-mentioned note of the Italian Consulate and the present note constituting an agreement on the subject between the two Governments.
