No. 4579. TRADE AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE ISLAMIC REPUBLIC OF PAKISTAN AND THE AUSTRIAN FEDERAL GOVERNMENT. SIGNED AT KARACHI, ON 24 DECEMBER 1956

The Government of the Islamic Republic of Pakistan and the Austrian Federal Government, desiring further to develop trade relations between the two countries have agreed as follows :

Article I

The competent Austrian authorities will, subject to their laws and regulations, treat import applications concerning commodities of Pakistan origin, especially those included in Schedule "A"² on terms not less favourable than those accorded to any other country.

Article II

The competent Pakistan authorities will, subject to their laws and regulations, treat import applications concerning commodities of Austrian origin, especially those included in Schedule "B"³ on terms not less favourable than those accorded to any other country.

Article III

Nothing contained in this agreement shall restrict importers and exporters in Pakistan and Austria from carrying on trade in accordance with the laws, rules and regulations in force in each country in goods not included in Schedules "A" and "B" appended to this agreement.

Article IV

Payments and other charges in connection with the import and export of commodities and goods as well as other payments between the two countries shall be made in pounds sterling unless otherwise agreed to by the Governments of the two countries.

Article V

During the currency of this agreement, the two Governments may, by mutual agreement, alter, extend or supplement the Schedules to this agreement.

Article VI

This agreement shall come into force with effect from the date of its signature and shall remain in force for a period of one year. It will be automatically renewed from year to year unless in any agreement year a notice of termination is given by either Party three months before the end of the agreement year.
