Your Excellency,

I have the honour to refer to Article 1 paragraph 4 of the Convention on the Rights and Obligations of Foreign Forces and their members in the Federal Republic of Germany<sup>2</sup> which provides that Sending States, other than the three Powers, may, by an agreement concluded with the three Powers or any one of them, after ascertaining the views of the Federal Government, assume, vis-à-vis the Federal Republic, all or certain of the rights and obligations arising out of the Convention, and that the remaining rights and obligations shall be assumed by one of the three Powers. The same provisions apply to the Finance Convention.<sup>3</sup>

I am instructed by my Government to propose that to this end the division of responsibility between our two countries for the rights and obligations in question should be in accordance with the following provisions which refer to all those Articles of the Forces Convention and of the Finance Convention in which mention is made either of "the Power concerned" or "the authorities of the Forces:"

Belgium to be the Power concerned for all the relevant Articles of the Forces and Finance Conventions with the following exceptions:

Forces Convention: Article 4; Article 7 (6); Article 17 (10); Article 18 (7).

for which the United Kingdom will be the Power concerned.

I am further instructed by my Government to propose that the Convention between our two Governments regarding the status of Belgian Forces in Germany signed at Brussels on December 23, 1949, 1 should terminate as from the date on which the present Agreement takes effect.

If these proposals are acceptable to the Belgian Government, I have the honour to suggest that this letter and Your Excellency's reply thereto shall constitute an Agreement between our two Governments in these matters, with effect from the date of the entry into force of the Protocol on the Termination of the Occupation Regime in the Federal Republic of Germany.

Your Excellency,

I have the honour to refer to Your Excellency's letter of 10 November 1955 concerning the application of article 1, paragraph 4 of the Convention on the Rights and Obligations of Foreign Forces and their members in the Federal Republic of Germany.

I am instructed by my Government to accept the proposal that the division of responsibility between our two countries for the rights and obligations in question should be in accordance with the following provisions which refer to all those articles of the Forces Convention and of the Finance Convention in which mention is made either of "the Power concerned" or "the authorities of the Forces."

"Belgium to be the Power concerned for all the relevant articles of the Forces and Finance Conventions with the following exceptions:

"Forces Convention: Article 4; Article 7 (6); Article 17 (10); Article 18 (7).

"for which the United Kingdom will be the Power concerned."

I am further instructed by my Government to accept the proposal that the Convention between our two Governments regarding the status of Belgian Forces in Germany, signed at Brussels on 23 December 1949, should terminate as from the date on which the present Agreement takes effect.

This reply, together with Your Excellency's above-mentioned letter, shall constitute an Agreement between our two Governments in these matters, with effect from the date of the cessation of the Occupation Regime in the Federal Republic of Germany.
