Monsieur l'Ambassadeur,

I have the honour to inform Your Excellency that it is the understanding of His Majesty's Government that all kinds of equipment, materials and livestock supplied to Thailand by Australia, and likewise those supplied to Australia by Thailand under the Colombo Plan, will be exempted from import duties of the two respective countries on the basis of reciprocity.

I have the honour, therefore, to request that Your Excellency be so good as to confirm the above understanding. Your reply so confirming and this Note will constitute an agreement between His Majesty's Government and Her Majesty's Government in the Commonwealth of Australia in this matter.
