No. 5102. ADDITIONAL CONVENTION¹ TO THE CONVENTIONS RELATING TO EXTRADITION BETWEEN BELGIUM AND AUSTRIA, SIGNED RESPECTIVELY ON 12 JANUARY 1881 AND 26 JANUARY 1932.² SIGNED AT VIENNA, ON 22 APRIL 1959

His Majesty the King of the Belgians and the Federal President of the Republic of Austria, considering it desirable to supplement by an additional convention the list of crimes and offences in respect of which extradition can be granted in accordance with the Extradition Conventions concluded between Belgium and Austria on 12 January 1881 and 26 January 1932,² have appointed as their plenipotentiaries :

His Majesty the King of the Belgians :

Mr. Georges Delcoigne, his Ambassador to the Republic of Austria;

The Federal President of the Republic of Austria :

Dr. Leopold Figl, Federal Minister for Foreign Affairs;

who, having exchanged their full powers, found in good and due form, have agreed as follows :

Article I

The following provisions shall be added to article 2 of each of the said Conventions :

36°. Illicit traffic in dangerous drugs, as envisaged in article 2 of the International Convention for the Suppression of the Illicit Traffic in Dangerous Drugs, signed at Geneva on 26 June 1936.³

Article II

This Convention shall be ratified; it shall come into force two months after the exchange of the instruments of ratification and shall remain in force with respect to Austria and the metropolitan territory of Belgium for the same period as the Convention of 12 January 1881 and with respect to Austria on the one hand and the Belgian Congo and the Territory of Ruanda-Urundi on the other hand, for the same period as the Convention of 26 January 1932.
