Monsieur le Chargé d'Affaires,

I have the honour to inform you that it is the understanding of His Majesty's Government that all kinds of equipment, materials and livestock supplied to Thailand by New Zealand, and likewise those supplied to New Zealand by Thailand under the Colombo Plan, will be exempted from import duties of the two respective countries on the basis of reciprocity.

I have the honour, therefore, to request that you be so good as to confirm the above understanding. Your reply so confirming and this Note will constitute an agreement between His Majesty's Government and the Government of New Zealand in this matter.
