The Secretariat of State for Foreign Affairs to Her Britannic Majesty's Embassy at Belgrade

The Secretariat of State for Foreign Affairs presents its compliments to Her Britannic Majesty's Embassy and, with reference to the Embassy's Note No. 72(1623) dated March 26, 1959, relating to the introduction of a "licence or crew member certificate of civil aviation" instead of passport and visa, has the honour to communicate as follows:

For the purpose of further developing and facilitating of air services between the Federal People's Republic of Yugoslavia and the United Kingdom of Great Britain and Northern Ireland, the Secretariat of State, on behalf of the Government, accepts the suggestion of Her Majesty's Principal Secretary of State for Foreign Affairs and proposes that passports and visas, carried by the crews of aircraft belonging to civil aviation enterprises of the two countries, should be replaced by "licences or crew member certificates of civil aviation", subject to the following conditions:

- 1) That the licence or crew member certificate is valid and is endorsed with a guarantee of re-entry facilities to the issuing country.
- 2) That the holder of such a licence or certificate, whatever his nationality, shall be a regular employee of an airline designated in accordance with the Air Services Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Federal People's Republic of Yugoslavia, signed at London on the 3rd of February, 1959, 2 to operate a regular air service between Yugoslavia and the United Kingdom.

- 3) (a) In the case of crew members employed by a designated airline of the United Kingdom, that a list of the names of such members shall be presented beforehand by the aviation authorities of the United Kingdom for approval by the aviation authorities of Yugoslavia;
  - (b) in the case of crew members employed by a designated airline of Yugoslavia, that a list of the names of the crew members of each aircraft shall, on its arrival in the United Kingdom, be presented to the immigration authorities of the United Kingdom.
- 4) The holders of a "licence or crew members certificate of civil aviation" are authorized to enter Yugoslavia or the United Kingdom without visa and to stay at the airport or in a city nearest to the airport. If the aircraft flies on a regular international service, the crew members should depart on the same aircraft in which they arrive or on the next regularly scheduled flight. If it is the matter of a specially permitted flight, the crew should depart on the same aircraft in which they arrive.

If this proposal is agreeable to Her Majesty's Embassy, the Secretariat of State suggests to conclude an Arrangement in this matter by exchanging notes of the same content, determining at the same time the date of entry into force of this Arrangement.

The Secretariat of State for Foreign Affairs avails itself of this opportunity to renew to Her Britannic Majesty's Embassy the assurance of its high consideration.

The Secretariat of State for Foreign Affairs presents its compliments to Her Britannic Majesty's Embassy and, with reference to the Embassy's Note No. 17 dated January 15, 1960, has the honour to communicate as follows:

Desirous of acceding to the request of the Government of the United Kingdom, the Yugoslav Government agrees to extend the Agreement for the mutual recognition of aircrew licences and certificates in lieu of visas, reached by the Exchange of Notes (the Secretariat's Note No. 9917/6/1959 and the Embassy's Note No. 177/1959) on July 22, 1959, <sup>2</sup> to air crews of other British companies, not only of the British European Airways, in so far and when other companies operate air services to Yugoslavia. The companies should submit in advance for approval a list of names of such crews to the Yugoslav authorities.

If the foregoing is acceptable to the Government of the United Kingdom, the Secretariat has the honour to propose that this Note and the Embassy's Note in reply concurring therein shall constitute an Agreement between our Governments on the extension of the said Agreement of the 22nd of July, 1959, taking effect from April 1, 1960.
