No. 5405. EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN ISRAEL AND ICELAND CONCERNING MUTUAL PROTECTION OF TRADE MARKS. STOCKHOLM, 15 JUNE 1960

Stockholm, June 15, 1960

Your Excellency,

Referring to the correspondence exchanged between our respective Legations regarding mutual protection of trade marks, I have the honour to state the following :

The Government of Iceland shall extend the benefits of the laws at the time being in force in Iceland in the matter of registration and protection of trade marks, subject to the limitations and conditions stated therein, to applications for the registration of trade marks, emanating from persons who have registered their trade marks in Israel.

The Government of Israel shall extend the benefits of the laws at the time being in force in Israel in the matter of registration and protection of trade marks, subject to the limitations and conditions stated therein, to applications for the registration of trade marks emanating from persons who have registered their trade marks in Iceland.

If the Government of Israel are prepared to accept the above provisions, I have the honour to suggest that the present Note and Your Excellency's reply in similar terms should be considered as constituting an Agreement between the two Governments. The Agreement's entry into force will take place two months after the date of exchange of these Notes.

Accept, Your Excellency, the assurance of my highest consideration.
