No. 5418. TRADE AGREEMENT¹ BETWEEN THE FEDERAL PEOPLE'S REPUBLIC OF YUGOSLAVIA AND THE UNION OF BURMA. SIGNED AT RANGOON, ON 29 JUNE 1953

The Government of the Federal People's Republic of Yugoslavia and the Government of the Union of Burma, desiring to promote economic co-ordination and trade between the two countries, have entered into a trade agreement as follows:

Article 1

The Government of the Union of Burma agrees to permit the exportation to Yugoslavia and the Government of the Federal People's Republic of Yugoslavia agrees to permit the importation into Yugoslavia of the commodities specified in Schedule "A" attached to this agreement.

Article 2

The Government of the Federal People's Republic of Yugoslavia agrees to permit the exportation to Burma and the Government of the Union of Burma agrees to permit the importation into Burma of the commodities specified in Schedule "B" attached to this agreement.

Article 3

This agreement shall not have the effect of restricting the flow of trade between the Union of Burma and the Federal People's Republic of Yugoslavia to the commodities mentioned in Schedules "A" and "B".

Article 4

In respect of such commodities as are, or may be, subject to export or import licence, the two Governments agree to grant upon application duly made, export or import licences in accordance with the laws and regulations and administrative practices of the Government granting the licence.

Article 5

In order to facilitate the implementation of this agreement, the two Governments agree to hold consultations with each other in respect of any matter arising

from or in connexion with the supply of commodities between the two countries during the currency of and in accordance with this agreement.

Article 6

This agreement shall come into operation on signature, and shall remain in force until the expiration of three months from the day on which either party may give notice of its intention to terminate it.

Done and signed, in duplicate, in English, either copy being authentic, in Rangoon, on this day, the 29th June, 1953.
